# 1. PLANETS, SIGNS, AND HOUSES

## 1.1 The classical planets

From the point of view of an earthbound observer, the stars of the night sky appear to be fixed-in-place on a concentric spherical surface that is called the **celestial sphere**. The noun ‘planet’ (whose Greek name means ‘wanderer’) was used to describe any object that appeared to wander along the celestial sphere. To peoples of the ancient world, these wanderers were the two **luminaries** *Sun* and *Moon* and the planets *Mercury*, *Venus*, *Mars*, *Jupiter*, and *Saturn*, all of which are visible to the naked eye. These seven wanderers are called the **classical planets**. The adjective ‘classical’ here means ‘standard and traditional’.

**Astrology** is the study of the behavior of celestial bodies in the belief that they indicate the course of human affairs. The term ‘**traditional astrology**’ refers to the combination of the Hellenistic tradition of astrology (which is a blending of Mesopotamian and Egyptian astrological traditions with Greek philosophical thought) and the subsequent contributions of ancient Roman, Medieval (Indian, Islamic, and European), and European Renaissance astrologers.

In traditional astrology, the classical planets intrinsically represent the fundamental essences that collectively characterize all persons, places, and things. Therefore, each classical planet is the natural representative of some subset of persons, places, or things.

The radiant and solar-system ruling **Sun** intrinsically represents vitality, self-esteem, volition, and leadership. Sun’s intrinsic attributes make it the natural representative of:

Fathers; leaders and bosses among people; recognition among social interactions; things that give life and energy; gold among metals; lions among animals; eagles among birds; diamonds among gemstones; the heart among organs; things that are yellow in color.

Spiritually speaking, Sun is the energy associated with Man’s will – one’s ability to deliberately decide on a course of action, one’s freedom to choose between right and wrong. Sun is nobly expressed whenever one asserts oneself with dignity by using their will to rise above course and unsavory things.

The faithfully reflecting and phase-changing **Moon** intrinsically represents receptivity, adaptability, and devotion. Moon’s intrinsic attributes make it the natural representative of:

Mothers; nurturers; compliant people; domestic matters; that which is watery or associated with water; emotions; stages of change; short-term travel; wandering; lost items; nocturnal entities; new things or newborn creatures; silver among metals; the stomach and the intestines among organs; the digestive system; things that are white in color.

Spiritually speaking, Moon is the energy associated with Man’s trance ability, which enables one to learn and to change. In a trance state, one has a heightened receptivity in which beliefs, images,

and words become empowered to create or undo habits. Moon is nobly expressed whenever one is receptive to and compliant with right guidance.

The swift-moving planet **Mercury** intrinsically represents mobility of thought, word, and deed. Mercury's intrinsic attributes make it the natural representative of:

Clever action; deception; ideas and beliefs; speech and all modes of communication; expertise; negotiations, trade, and transactions; exact sciences and calculations; transportation; things that imitate humans; wind and everything that causes it; small items coming in large numbers; things of mixed composition; mercury among metals; the tongue and the vocal cords among organs; the nervous system; things that are multicolored.

Spiritually speaking, Mercury is the energy associated with Man's verbal mind – one's ability to think logically and to express oneself through words. Mercury is nobly expressed whenever one uses their cleverness and verbal facility to further that which is wholesome.

The planet **Venus** (whose Latin name means 'love') intrinsically represents affection, enjoyment, attractive power, and harmony. Venus's intrinsic attributes make it the natural representative of:

Friendly action; intimate (that is, closely personal) relationships; social activities; personal charm; charisma; that which is attractive or beautiful; that which is fragrant; that which is sweet or delicious; that which is pleasing to the touch; arts and entertainment; copper among metals; the kidneys and the thyroid gland among organs; the vagina and the uterus among female organs; fertility; things that are green in color.

Spiritually speaking, Venus is the energy associated with Man's visual mind – one's imagination, which enables one to form mental images. When intensely entertained with aroused feelings of enjoyment, mental images gain the power to attract the necessary resources for their realization. Venus is nobly expressed whenever through joyful optimism, one attracts the necessary resources for faring well.

The blood-red planet **Mars** intrinsically represents courage, enthusiasm, assertiveness, and pioneering. Mars's intrinsic attributes make it the natural representative of:

Aggressive action (that is, energetic assertive action or hostile action); athletic skill; bodily injury; that which is hot or burning like fire; things that are sharp or cutting; that which causes bleeding; iron among metals; the gallbladder and the adrenal glands among organs; the penis and the testicles among male organs; the muscular system; things that are red in color.

Spiritually speaking, Mars is the energy associated with Man's sense of justice. Being just with all people in all situations requires one to have a warrior's courage and zeal for righteousness, even at the cost of personal loss. Mars is nobly expressed whenever one has the courage to take right action.

The huge and gaseous planet **Jupiter** intrinsically represents virtuous optimism (that is, the belief that virtuous action eventually brings the best outcome) and expansion (material and spiritual). Because one's optimism draws positive circumstances to oneself, Jupiter is the bringer of good luck (that is, favorable circumstances that are beyond willful control). Jupiter's intrinsic attributes make it the natural representative of:

Noble-minded action; high social position; religion/spirituality; science and law among professions; tin among metals; money and luxury items among possessions; that which is large or spreading; sources of fertility and abundance; tin among metals; the liver and the pancreas among organs; adipose tissue (body fat); things that are purple in color.

Spiritually speaking, Jupiter is the energy associated with Man's moral sense – one's intuitive ability to distinguish right from wrong. Jupiter is nobly expressed whenever one acts with good character and good judgment.

The ringed and slow-moving planet **Saturn** intrinsically represents restriction, structure, and slow change. Saturn is the bringer of challenges that require patient perseverance in order for one to prevail. Saturn's intrinsic attributes make it the natural representative of:

Sober-minded action; restraints and limitations; rules and regulations; hierarchical organization; that which is hard and heavy; that which is lonely or isolated; chronic ailments; that which is old and decaying; death; that which is freezing and preserving; lead among metals; the spleen among organs; the skeletal system; the teeth; the skin, hair, and nails as body protection; things that are black in color.

Spiritually speaking, Saturn is the energy associated with Man's ability to patiently persevere (that is, to calmly remain constant to a purpose in spite of obstacles). Saturn is nobly expressed whenever one stabilizes one's heart (that is, one's prevailing mental and emotional attitude), so that one may think clearly and respond properly to situations in life, instead of reacting according to habit or impulse.

## 1.2 Sun's yearly cycle and the zodiac

The notion of a time period called 'a year' is tied to Earth's annual orbit about Sun. From the point of view of an earthbound observer, Earth remains at rest while Sun orbits it along the celestial sphere. As Sun makes its orbit, it moves along a great-circular path called the **ecliptic**. In our imagination, let's thicken this circular path into a circular belt that extends about 8 angular degrees on each side of the ecliptic. As seen from Earth, the classical planets all wander within this circular belt called the **zodiac**.

On the celestial sphere, a **constellation** is a grouping of fixed stars that is believed to resemble a person, animal, or inanimate object. As Sun makes its annual journey along the zodiac, it passes through portions of fourteen constellations. Going forward along the zodiac, the names of these constellations are **Aries** (whose Latin name means 'ram'), **Taurus** (whose Latin name means 'bull'), **Gemini** (whose Latin name means 'twins'), **Cancer** (whose Latin name means 'crab'), **Leo** (whose Latin name means 'lion'), **Virgo** (whose Latin name means 'virgin'), **Libra** (whose Latin name means 'scales'), **Scorpio** (whose Latin name means 'scorpion'), **Ophiuchus** (whose Greek name means 'serpent-bearer'), **Sagittarius** (whose Latin name means 'archer'), **Capricorn** (whose Latin name means 'horned goat'), **Aquarius** (whose Latin name means 'water-bearer'), **Pisces** (whose Latin name means 'fishes'), and **Cetus** (whose Latin name means 'sea monster' or 'whale').

Within the 360° of the zodiacal belt, the aforementioned fourteen constellations are generally unequal in angular expanse.<sup>1</sup> In this regard, TABLE 1.2a presents the time that Sun spends in each constellation during its annual journey. Note that while traveling through Pisces, the southern edge of Sun’s disk overlaps with Cetus for about fourteen hours.

At some time long ago, Mesopotamian astrologers conceived of dividing the zodiacal belt into twelve equal regions (called **signs**), each region having an angular expanse of 30°. They ignored the Cetus constellation and considered the Scorpio and Ophiuchus constellations in combination. This concept is called the **sidereal zodiac**. The names of the twelve sidereal signs are *Aries*, *Taurus*, *Gemini*, *Cancer*, *Leo*, *Virgo*, *Libra*, *Scorpio*, *Sagittarius*, *Capricorn*, *Aquarius*, and *Pisces*. Each sidereal sign is occupied predominantly by the constellation after which it is named.

At some later time, astrologers conceived of dividing the zodiacal belt into twelve equal signs, each corresponding to approximately one month of Sun’s annual journey along the zodiac. See TABLE 1.2b for pertinent details. This concept is called the **tropical zodiac**. The names of the

twelve tropical signs are *Aries, Taurus, Gemini, Cancer, Leo, Virgo, Libra, Scorpio, Sagittarius, Capricorn, Aquarius, and Pisces*. Although each tropical sign is the namesake of a sidereal sign, tropical sign *X* is generally not the same zodiacal region as sidereal sign *X*. Each tropical sign refers to a stage of Earth's annual cycle of seasons.

The celestial equator is the projection of Earth's equator onto the celestial sphere. The **equinoxes** are the two points where the ecliptic intersects the celestial equator. The tropical zodiac is a season-based sign arrangement that takes tropical Aries 0° to be the position of Sun at the March equinox. Sun spends about a month in each sign as it goes forward along the zodiac. Between the March equinox and the June solstice, Sun travels through the tropical signs of Aries, Taurus, and Gemini. Between the June solstice and the September equinox, Sun travels through the tropical signs of Cancer, Leo, and Virgo. Between the September equinox and the December solstice, Sun travels through the tropical signs of Libra, Scorpio, and Sagittarius. Between the December solstice and the March equinox, Sun travels through the tropical signs of Capricorn, Aquarius, and Pisces.

Like the axis of a spinning top, Earth's rotational axis undergoes a slow, cyclical change in which it traces a cone-shaped path over time. This wobbling motion of Earth's rotational axis is called *axial precession*. As a result of axial precession, the equinoxes slowly move westward along the ecliptic (that is, backward along the zodiac), thereby giving rise to the **precession of the equinoxes**. Consequently, we perceive each fixed star to move forward along the tropical zodiac at a varying rate, currently about 50.29" of arc per year (which amounts to about 01° every 72 years). In this regard, sidereal Aries 0° is usually not the same as tropical Aries 0° (the March equinox point). The angular difference between sidereal Aries 0° and tropical Aries 0° is called the **ayanāṃśa**. See Section 2.1 for pertinent details.

## 1.3 The twelve signs

In traditional astrology, each classical planet rules a number of zodiacal signs. Sun rules Leo. Moon rules Cancer. Mercury rules Virgo and Gemini. Venus rules Libra and Taurus. Mars rules Scorpio and Aries. Jupiter rules Sagittarius and Pisces. Saturn rules Capricorn and Aquarius.

One's personality is one's characteristic way of thinking, feeling, and behaving. Each sign is a personality expression of its ruling planet. Its **gender** refers to whether it is a masculine or feminine expression. **Masculine energy** is centrifugal, expansive, or externalizing. **Feminine energy** is centripetal, contractive, or internalizing. See TABLE 1.3a for pertinent details.

On examining TABLE 1.3a, we see that sign gender alternates between masculine and feminine as we sequentially go forward along the zodiac. The table also shows a pattern involving the sign rulers. Let's view Sun and Moon here as the respective masculine and feminine expressions of a planet called *Luminary*. As we go from Leo to Capricorn, the order of the sign rulers is: Luminary, Mercury, Venus, Mars, Jupiter, Saturn. As we go from Aquarius to Cancer, the order of the sign rulers is: Saturn, Jupiter, Mars, Venus, Mercury, Luminary (which is the reversal of the previous order).

Fire, earth, air, and water symbolize the fundamental elements of human personality. **Fire** symbolizes the desires that burn within us. **Earth** symbolizes our physicality. **Air** symbolizes the thoughts that blow around in our mental sky. **Water** symbolizes our emotional and intuitive feelings. We may categorize the twelve signs into four sets of three (called **triplicities**) that each correspond to a particular element of personality. See TABLE 1.3b for pertinent details.

In addition to categorizing the zodiacal signs according to personality elements, we may categorize them according to modes of operation. We may liken these modalities to stages within any season of the year. The **cardinal modality** is related to a season’s beginning stage, and it refers to the tendency to initiate action and to create change. The **fixed modality** is related to a season’s middle stage, and it refers to the tendency to be determined and to resist change. The **dual modality** is

related to a season's ending stage, and it refers to the tendency to be adaptable and to embrace change. The dual modality has attributes of both the cardinal and fixed modalities. We may categorize the twelve signs into three sets of four (called **quadruplicities**) that each correspond to a particular mode of operation. See TABLE 1.3b for pertinent details.

Note that the portrayal of each dual sign involves some type of twoness. Gemini is portrayed as two twins. Virgo is portrayed as a winged maiden. Sagittarius is portrayed as a centaur, which is half-man and half-horse. Pisces is portrayed as two fishes.

The sign **Aries** (whose Latin name means 'ram') expresses Mars in a masculine way. As a fire sign, Aries is desirous, energetic, and forthright. As a cardinal sign, Aries initiates action and creates change. Like a combative ram, Aries likes challenges and has an abundant amount of physical energy. Aries is courageous and pioneering – he is always ready to take risks. In his eagerness to get things done, he is inclined to act first and think later. Like a charging ram, he rushes headlong into situations without considering the consequences. At his best, masculine Aries has the courage to jump into action in order to enthusiastically pursue worthy goals.

The sign **Taurus** (whose Latin name means 'bull') expresses Venus in a feminine way. As an earth sign, Taurus is grounded and focused on material stability. As a fixed sign, Taurus is determined and resistant to change. She holds on to anyone and anything that she views as her own. Like a charging bull focused on his target, Taurus stays set on her course. She wants to see tangible results from her efforts, and so she is inclined to getting absorbed in acquiring material comforts and in indulging herself. At her best, feminine Taurus is doggedly determined to make tangible progress in achieving a better quality of life.

The sign **Gemini** (whose Latin name means 'twins') expresses Mercury in a masculine way. As an air sign, Gemini is intellectual, communicative, and social. As a dual sign, Gemini is adaptable and embraces change. The twins represent both multiplicity and communication. Gemini expresses multiplicity through his versatility – he is curious, is quick to learn, and can do many things competently. He enjoys communicating his thoughts and feelings with others. Gemini thrives in environments of continuous activity and change. At his best, masculine Gemini seeks to learn and communicate in order to further wholesome intellectual development.

The sign **Cancer** (whose Latin name means 'crab') expresses Moon, which is the feminine luminary. As a water sign, Cancer is emotional, intuitive, and empathetic. As a cardinal sign, Cancer initiates action and creates change. Cancer is caring and protective – she is motivated to create a secure environment for herself and her loved ones. Like a crab clinging to its shell, Cancer is strongly attached to her roots, and she clings to anyone and anything that she finds comfortable and familiar. She takes offense easily and holds on to negativity from past experiences. At her best, feminine Cancer safeguards those who are near and dear.

The sign **Leo** (whose Latin name means 'lion') expresses Sun, which is the masculine luminary. As a fire sign, Leo is desirous, energetic, and forthright. As a fixed sign, Leo is determined and resistant to change. Like the roaring kingly lion, Leo wants others to take notice of him and to somehow revolve around him. Leo likes things to be done his way, takes pride in his achievements,

and seeks due recognition. If he becomes conceited, domineering, or ostentatious, then he loses the goodwill and admiration that he enjoys. At his best, masculine Leo acts nobly and safeguards those for whom he is responsible.

The sign **Virgo** (whose Latin name means ‘virgin’) expresses Mercury in a feminine way. As an earth sign, Virgo is grounded and focused on material stability. As a dual sign, Virgo is adaptable and embraces change. Virgo has a keen eye for detail, which enables her to approach problems with logic and efficiency. Being analytical and pragmatic, she can adjust to changing circumstances while keeping a focus on detail and order. Like a virgin, Virgo sets a high standard for herself. If she sets her expectations too high, then she faces disappointment and a pessimistic outlook on life. At her best, feminine Virgo uses calculated thinking to determine how to make life run more smoothly for everyone.

The sign **Libra** (whose Latin name means ‘scales’) expresses Venus in a masculine way. As an air sign, Libra is intellectual, communicative, and social. As a cardinal sign, Libra initiates action and creates change. Like the justice scales, Libra seeks balance and harmony. He initiates relationships and partnerships with a diplomatic approach. He may have a difficult time making decisions as he weighs up all the pros and cons. He finds ugliness in people and things distasteful – he seeks to be surrounded by beauty and harmony. At his best, masculine Libra inclines toward justice and strives for fairness in all situations.

The sign **Scorpio** (whose Latin name means ‘scorpion’) expresses Mars in a feminine way. As a water sign, Scorpio is emotional, intuitive, and empathetic. As a fixed sign, Scorpio is determined and resistant to change. Like a scorpion’s claws, Scorpio is tenacious – she tightly holds on to people and things. She takes relationships seriously and is intensely loyal to her friends. Moreover, she carries her goals to fruition with unshakable resolve. Scorpio has a sharp insight that helps her to accurately size up people and things. If she feels threatened, then she is inclined to become angry and vengeful. At her best, feminine Scorpio is driven by a deep sense of purpose, and she is not easily deterred by obstacles or setbacks.

The sign **Sagittarius** (whose Latin name means ‘archer’) expresses Jupiter in a masculine way. As a fire sign, Sagittarius is desirous, energetic, and forthright. As a dual sign, Sagittarius is adaptable and embraces change. The ancients imagined Sagittarius as a centaur, which is a mythical half-horse and half-man creature. The half-horse represents the need to explore new things. The half-man is an archer who shoots his arrow into the air and then optimistically follows its trail. Sagittarius is adventurous and optimistic – he enjoys exploring new ideas, new experiences, and new philosophies. At his best, masculine Sagittarius is not afraid to go beyond his comfort zone and to take risks in order to achieve worthy goals.

The sign **Capricorn** (whose Latin name means ‘horned goat’) expresses Saturn in a feminine way. As an earth sign, Capricorn is grounded and focused on material stability. As a cardinal sign, Capricorn initiates action and creates change. Capricorn is ambitious and success-driven – she seeks social accomplishment through her goals and long-term plans. Like a mountain goat, Capricorn climbs cautiously to the summit of success, leaving behind those who are less resolute. If she gets absorbed in her pursuits, then she tends to become unconcerned about anyone and

anything perceived as inconsequential to her success. At her best, feminine Capricorn is diligent – she gives steady, meticulous attention to ongoing tasks.

The sign **Aquarius** (whose Latin name means ‘water-bearer’) expresses Saturn in a masculine way. As an air sign, Aquarius is intellectual, communicative, and social. As a fixed sign, Aquarius is fixed in his ideals and is often resistant to following conventional rules. The ancients imagined Aquarius as a person who is carrying life-giving waters and pouring them over the earth. Aquarius desires to make a positive impact on the world, and he thinks often about how to improve people’s lives. He works well in groups, but he may have difficulty being intimate one-on-one. At his best, masculine Aquarius is unselfish and makes improvements for the common good.

The sign **Pisces** (whose Latin name means ‘fishes’) expresses Jupiter in a feminine way. As a water sign, Pisces is emotional, intuitive, and empathetic. As a dual sign, Pisces is adaptable and embraces change. The ancients imagined Pisces as two fishes swimming in opposite directions, representing emotional versatility. Pisces is compassionate and intuitive – she can easily empathize with others, adapting to emotional shifts with ease. She is compassionate and tends to see the best in others. If others abuse her kindheartedness, then she may develop a victim mentality in which she perceives herself as being constantly wronged or powerless over her circumstances. At her best, feminine Pisces is resilient and shows kindly concern for others.

We say that two signs are **opposite signs** if each one is 6 neighbors away from the other. Aries and Libra are opposite signs. Taurus and Scorpio are opposite signs. Gemini and Sagittarius are opposite signs. Cancer and Capricorn are opposite signs. Leo and Aquarius are opposite signs. Virgo and Pisces are opposite signs.

## 1.4 Sun’s daily cycle and the angles

The notion of a time period called ‘a day’ is tied to Earth’s daily rotation about its line of poles. From the point of view of an earthbound observer, Earth remains at rest while the celestial sphere rotates about its line of poles (which are the same as Earth’s line of poles). Because the zodiacal belt is attached to the celestial sphere, it likewise rotates about the line of poles. During the course of a day, Sun does not move very much along the zodiac, and so we may take Sun to be attached to the zodiacal belt. As the zodiacal belt rotates about the line of poles, Sun rotates with it, and so Sun makes a daily journey across the sky during which one experiences daytime (when Sun is above the horizon) and nighttime (when Sun is below the horizon).

The **local horizon** is the local plane at which Earth’s surface and the sky appear to meet. If we parallel-transport this plane until it meets Earth’s center, then we get the **geocentric horizon**. In astrology, we are considering distant celestial bodies, and so the difference between the local and geocentric horizons is negligible. The intersection of the geocentric horizon with Earth is a great circle. The **horizon circle** is the projection of this great circle onto the celestial sphere. From here onward, we will take the noun ‘horizon’ to refer to the horizon circle.

Four important points of Sun's daily journey are the **sunrise point** (that is, Sun's location at sunrise), the **noon point** (that is, Sun's location at noon), the **sunset point** (that is, Sun's location at sunset), and the **midnight point** (that is, Sun's location at midnight). Here we take sunrise to be the instant when Sun meets the eastern part of the observer's horizon. Similarly, we take sunset to be the instant when Sun meets the western part of the observer's horizon. The sunset point is opposite the sunrise point. Here we take noon to be the instant when Sun meets the observer's **meridian** (that is, the projection of the local geographic longitudinal line onto the celestial sphere), thereby reaching its highest position above the horizon on that day and casting the shortest shadow. In this regard, we take midnight to be the instant when it is noon at the opposite end of Earth. The midnight point is opposite the noon point.

In astrology, the sunrise point is called the **Ascendant**, and the sunset point is called the **Descendant**. Each of these points is an intersection between the ecliptic and the horizon. In astrology, the noon point is called the **Midheaven** (or **Medium Coeli**, meaning 'middle of the sky'), and the midnight point is called the **Imum Coeli** (meaning 'bottom of the sky'). Each of these points is an intersection between the ecliptic and the meridian. The Ascendant, the Descendant, the Midheaven, and the Imum Coeli are collectively called the **angles**.

On page 109 of his book *Flash of the Spirit*, art historian and writer Robert Farris Thompson speaks about the Kongo cosmogram called the **yowa cross**.<sup>2</sup> This cross involves a horizontal line that intersects a vertical line. There is a small disk at each end of both lines. Thompson states that "the four disks at the points of the cross stand for the four moments of the sun", which are the four angles. Thompson states that "the horizontal line divides the mountain of the living world from its mirrored counterpart in the kingdom of the dead." Regarding the vertical line, Thompson states that:

"The summit of the pattern symbolizes not only noon but also maleness, north, and the peak of a person's strength on earth. Correspondingly, the bottom equals midnight, femaleness, south, the highest point of a person's otherworldly strength."

In traditional African cultures, one reaches the peak of one's otherworldly strength whenever one becomes an honorable ancestor.

Let's use knowledge from the *yowa* cross as a starting point for coming to an astrological interpretation of the four angles. The horizon is the dividing line between masculine and feminine areas of life. Masculine energy is centrifugal, expansive, or externalizing. Feminine energy is centripetal, contractive, or internalizing. The Ascendant (the sunrise point) represents one's entry into the physical world, which involves bodily life (that is, the incarnation of one's immortal soul into a mortal body). Here one leaves the feminine spirit world and enters the masculine physical world. The Descendant (the sunset point) represents one's exit from the physical world, which involves bodily death. Here one leaves the masculine physical world and enters the feminine spirit world. The Midheaven (the noon point) represents making it to the top in earthly life. Here one gains prestige (that is, high status that is achieved through success, influence, or other favorable attributes). The Imum Coeli (the midnight point) represents ancestral lineage, traditions, and remembrance. Those who live righteous and truthful lives in the physical world are on the way to becoming honorable ancestors, thereby making it to the top in the spirit world.

In traditional astrology, the local sky (above and below the horizon) is divided into twelve sectors called **houses**. Each astrological house refers to some subset of areas of human life. The 1st through 6th Houses lie below the horizon, and they refer to areas of one's life that are somewhat private. The 7th through 12th Houses lie above the horizon, and they refer to areas of one's life that are somewhat public.

The Ascendant-Descendant (or horizon) axis is the boundary between the upper sky (which contains the Midheaven) and the lower sky (which contains the Imum Coeli). The Medium-Imum Coeli (or meridian) axis is the boundary between the eastern sky (which contains the Ascendant) and the western sky (which contains the Descendant). A **quadrant-house system** uses the horizon and meridian axes to divide the local sky into four quadrants, each containing three houses. The varying angular sizes of these quadrants result in houses of unequal angular size. The **cusps** of a house is the dividing line that marks the beginning of that house. In a quadrant-house system, the Ascendant is the 1st-House cusp, the Descendant is the 7th-House cusp, the Midheaven is the 10th-House cusp, and the Imum Coeli is the 4th-House cusp. The locations of other house cusps depend on how the quadrant-house system is defined.

## 1.5 The twelve houses

Here we will explore the 12 astrological houses as they come to us from the Hellenistic tradition of astrology. This tradition uses the notion of **planetary joys**, which says that each classical planet has an affinity for a particular house where it functions naturally.

TABLES 1.5a and 1.5b present some meanings of the various houses. Note that the information in these tables usually refers to one's own self. For example, the 3rd-House item 'siblings' refers to one's own siblings, not someone else's siblings.

The **1st House** takes after the Ascendant (the sunrise point), which represents bodily life (and by extension, bodily health). In the Hellenistic tradition, the 1st House is called the 'helm', which is the part of a ship from which it is steered. The 1st House refers to the persona, which is the vehicle of personality (that is, characteristic way of thinking, feeling, and behaving) through which one navigates earthly life. The 1st House refers to the physical body (and by extension, any physical vehicle in which one travels), which is the 'ship' that one steers through the physical world. The 1st House refers to one's well-being (that is, state of being happy, healthy, and prosperous). The 1st House is Mercury's joy. Mercury is versatile (that is, capable of doing many things competently), and so he rejoices in the diversity of human individuality.

In the Hellenistic tradition, the **2nd House** is called 'the place of livelihood', which refers to one's means of maintaining one's physical existence. The 2nd House refers to supportive persons or things, which are one's resources (that is, sources of aid or support that can be readily drawn from when needed). These resources are food (as sustenance), money, transportable possessions, and helpful people on whom one can rely.

In the Hellenistic tradition, the **3rd House** is called ‘the place of motherly God’. The 3rd House refers to early development. Man’s ability to learn and to change is based on trance, which is feminine (that is, internalizing) in nature. Trance is a state of heightened receptivity in which beliefs, images, and words become empowered to create or undo habits. Early education involves reading, writing, and arithmetic, and it aims at developing one’s basic knowledge and skills. Learning involves interacting with others. Interacting with siblings helps to build one’s sense of community (that is, a sense of “one for all and all for one”). Eventually one begins interacting with others, which involves travel within one’s neighborhood or to nearby regions. The 3rd House is Moon’s joy. Moon is the energy associated with Man’s trance ability.

The **4th House** takes after the Imum Coeli (the midnight point), which represents ancestral lineage, traditions, and remembrance. In the Hellenistic tradition, the 4th House is called ‘the underground place’, which refers to the Imum Coeli as being Sun’s bottommost point below the horizon. The 4th House refers to roots and home. The roots of a plant are its underground section that serves as its support and through which it draws nutrients from the surrounding soil. One’s roots are one’s ancestral guardians in the ‘underground’ spirit realm. One’s immediate roots are one’s parents. Ancestors have left a legacy of traditional know-how, which are ways of doing things that are handed down from generation to generation. The house where one’s family lives is where the family ‘puts down roots’ (that is, makes its home), where one expects comfort and security. As

The 4th House refers to underground places, such as wells, graves, and buried treasures. In this regard, the 4th House can refer to being gravebound (that is, headed for bodily death).

In the Hellenistic tradition, the **5th House** is called 'the place of good fortune' in relation to Man's physical body. The 5th House refers to children and personal interests (that is, activities that one pursues for enjoyment and satisfaction). Fertility and pregnancy are necessary for having children. Recreational activities (such as sex, entertainment, hobbies, sports, and theatres) restore one's spirits by enjoyment and relaxation, thereby helping one to feel childlike. Ambassadors and similar representatives are others who negotiate on behalf of one's personal interests. The 5th House is Venus's joy. Venus intrinsically represents affection, enjoyment, attractive power, and harmony, and it is the energy associated with Man's imagination.

In the Hellenistic tradition, the **6th House** is called 'the place of bad fortune' in relation to Man's physical body. The 6th House refers to sickness and servitude. Acute (that is, short-term and severe) illness is referred to here. Physical or mental stress often leads to illness. 'Unwholesome influences' not only refer to things that are detrimental to physical or mental health, but also to things that are morally harmful. On a negative note, the noun 'servitude' refers to the ill condition of being forced to serve another person. On a positive note, the noun phrase 'being of service' refers to voluntarily offering help to others. Subordinates are those of a lower rank, who are subject to the authority of a superior. Small animals (up to the size of a goat) are more easily domesticated,

thereby becoming subordinates in one's household. The 6th House is Mars's joy – the aggressive nature of Mars is on full display here.

We say that two houses are opposite houses if each one is 6 houses ahead (or equivalently 6 houses behind) the other. For example, the 1st and 7th Houses are opposite each other. Note that one meaning of the adjective 'opposite' is 'being the other of two complementary things'. In this regard, opposite houses are two halves of a whole.

The **7th House** takes after the Descendant (the sunset point), which represents bodily death (and by extension, bodily harm). In the Hellenistic tradition, the 7th House is called 'the setting place', which refers to the Descendant as being the point where Sun sets. The Descendant's meaning of death is usually taken here in the figurative sense of dying to a life of 'me' in order to be reborn to a life of 'we'. The 7th House refers to partnerships, which are agreements in which parties cooperate to further mutual interests. Matters of love involve romantic partnerships. A spouse is one's partner in marriage. A contract is a formal agreement between parties entering into a partnership. In a transactional relationship, each party does things for the other, expecting to get something in return. Heavenly cooperation involves partnering with the heavenly realm (that is, the abode of Creator God, ministerial divine entities, and honorable ancestors). In *Ifá* (a traditional African spiritual system), there is the notion that the *egbé* (comrades of heaven) are the *bòròkìnní òrun* (respectable persons of the spirit world) who will not let *bòròkìnní ayé* (respectable persons of earth) fall into disgrace.

Because the 7th House is opposite the 1st House, it takes on some opposite meanings. While the 1st House refers to oneself, the 7th House refers to someone else. This 'someone else' is sometimes an opponent (that is, someone who acts contrarily to one's interests or welfare). The Descendant's meaning of death can sometimes be taken literally. While the 1st House refers to bodily life or bodily health, the 7th House refers to bodily death or bodily harm.

In the Hellenistic tradition, the **8th House** is called 'the inactive place', which we will take to refer to death as the permanent end of some type of activity. The 8th House refers to death. Whether taken literally or figuratively, death is an ending that facilitates transformation. Because the 8th House is opposite the 2nd House, it takes on some opposite meanings. While the 2nd House refers to one's own resources, the 8th House refers to someone else's resources, which may be an inheritance (which is something inherited as a result of another's bodily death) or one's own debts (which are what one owes another).

In the Hellenistic tradition, the **9th House** is called 'the place of fatherly God'. The 9th House refers to higher development. Religion/spirituality is a means to spiritual elevation. Magic is the use of incantations and suitable materials to invoke spiritual energies to influence events. Higher education aims at developing one's know-how with regard to some type of profession, at the end of which is some type of certification. Travel broadens the mind, and long-distance travel exposes one to foreign countries and foreign people. Religion/spirituality, higher education, and long-distance travel call one to expand the range of their knowledge, experience, and interest. The 9th House is Sun's joy. Sun is nobly expressed whenever one asserts oneself with dignity by using one's will to rise above course and unsavory things.

The **10th House** takes after the Midheaven (the noon point), which represents making it to the top in earthly life. In the Hellenistic tradition, the 10th House is called ‘the place at the top’, which refers to the Midheaven as being Sun’s topmost point above the horizon. The 10th House refers to ‘making it to the top’ (that is, reaching a position of prominence). One’s vocation is an occupation (that is, something to which one devotes time and energy) that could be a calling (that is, a pursuit to which one is drawn) or a career (that is, a chosen pursuit). Through one’s vocation, one achieves something significant and gains prestige. A head person is at the top in that they are in charge of someone/something. Being on top of a situation means to be in full control of it. The 10th House can refer to high places, such as mountains, roofs, and a building’s upper floors.

In the Hellenistic tradition, the **11th House** is called ‘the place of good spirit’, which refers to goodwill (that is, an attitude of kindly interest). The 11th House refers to friends and benefactors. One’s friends take a kindly interest in one’s life and offer their help. Shared interests can bring people together as comrades. Goodwill from the heavenly realm leads to the fulfillment of wishes. The 11th House is Jupiter’s joy. Jupiter is the energy associated with Man’s moral sense, through which one has the noble-mindedness that is necessary to be morally upright, to judge rightly, and to exhibit loving-kindness.

In the Hellenistic tradition, the **12th House** is called ‘the place of bad spirit’. The 12th House refers to unpleasant limitations. One’s trying situations subject them to difficulties that test their character and resiliency. On page 96 of his book *Maat, the 11 Laws of God*, Ra Un Nefer Amen<sup>3</sup> says: “... as long as you are anything less than the vehicle of God, you will go through experiences that will make you suffer as spurs to your spiritual realization.” Therefore, on the path of spiritual ascension, one will experience trials and tribulations.

Here is more on unpleasant limitations. Chronic (that is, long-term) illness works against good health. Self-undoing involves actions that have negative consequences for the person doing them. Hidden enemies are people and things that work against one’s well-being without one being aware of it. A hex is an incantation that is aimed at bringing bad luck to someone. Hospitals, prisons, and other places of confinement keep people or things within specific bounds and allow limited access. The 12th House is Saturn’s joy – the restrictive nature of Saturn is on full display here.

Because the 12th House is opposite the 6th House, it takes on an opposite meaning. While the 6th House refers to small animals (up to the size of a goat), the 12th House refers to large animals (beyond the size of a goat).

**IMPORTANT COMMENTS:** A house can take on a derived meaning that is based on its position relative to another house. For example, consider the 7th House, which refers to one’s spouse. We may view one’s 7th House as the spouse’s 1st House. It follows that one’s 8th House is the spouse’s 2nd House, thereby referring to the spouse’s resources. Moreover, one’s 9th House is the spouse’s 3rd House (the spouse’s siblings), one’s 10th House is the spouse’s 4th House (the spouse’s parents), and so on. In this regard, the spouse’s houses are called **derived houses**.

## 1.6 The astrological chart

TABLE 1.6 presents the sign longitude of each classical planet, according to the sidereal zodiac, as observed at my time and place of birth. A planet's **sign longitude** is the zodiacal sign in which it appears, together with its **sign degree** (that is, its numerical degree within its hosting sign). The *ayanāṃśa* here is 23° 13' 14" according to True Chitrā 0° Libra.

TABLE 1.6 also presents the motion of each planet as seen from Earth. A planet is said to be in **direct motion** if it appears to move forward along the zodiac. A planet is said to be in **retrograde**

**motion** if it appears to move backward along the zodiac. A planet is said to be **stationing** if it appears to be standing still, which occurs when it transitions between direct and retrograde motion.

There are many ways of dividing the local sky into 12 houses. The astrological chart of FIGURE 1.6 presents the information of TABLE 1.6 according to the **whole-sign house system**, in which each house is tied to a single sign. In this ecliptic-based system, the 1st House is tied to the **rising sign** (that is, the sign of the Ascendant), the 7th House is tied to the sign of the Descendant, but the 10th and 4th Houses are not always tied to the respective signs of the Midheaven and the Imum Coeli.

In this book, we will be using the sidereal zodiac and the whole-sign house system as our foundation. Upon this foundation, we will be overlaying Porphyry houses as nuances. As a quadrant-house system, the **Porphyry house system** uses the horizon and meridian axes to divide the sky into four quadrants, each containing three houses. Moreover, the three Porphyry houses within a given quadrant are equal in angular expanse. We will use the denotation 'PH $n$ ' to mean 'Porphyry House  $n$ ' and the denotation 'PC $n$ ' to refer to its cusp. Note that the angles are PC1 (the Ascendant), PC4 (the Imum Coeli), PC7 (the Descendant), and PC10 (the Midheaven).

As an example of the Porphyry overlay, consider Mercury in my natal Capricorn 8th House. PH9 (the Porphyry 9th House) extends from Capricorn 19° 54' up to Aquarius 11° 40'. Therefore, Mercury at Capricorn 26° 59' lies in the intersection of Capricorn 8th House and PH9. This means that Mercury refers to someone/something that is a blending of 8th-House and 9th-House qualities.

Regarding the astrological charts in this book, I have designed the rectangular-chart framework to mimic the circular-chart framework used by many astrologers. The houses appear in ascending numerical order as we go counterclockwise in the chart. More specifically, the 12th House always appears in the upper left-hand corner, the 2nd House always appears in the lower left-hand corner, the 6th House always appears in the lower right-hand corner, and the 8th House always appears in the upper right-hand corner. Note that as we go counterclockwise in the chart, we go forward along the zodiac.

An astrological chart is a visual representation that is related to Sun's daily and yearly movements. Firstly, the division of the local sky into 12 houses is related to Sun's daily journey above and below the horizon. In this regard, suppose that we (at a fixed location) were to compare various astrological charts, all for the same day, but for different times of day. As the hours go forward in time, we would see chart-wise that Sun changes its house location in descending numerical order. More specifically, Sun rises in the east at the Ascendant, culminates at the Midheaven, sets in the west at the Descendant, and anti-culminates at the Imum Coeli. Each planet, sign, and fixed star moves in the sky in a similar way. This apparent rising, culminating, setting, and anti-culminating of planets, signs, and fixed stars is associated with Earth's axial rotation, and it is called **primary motion**. From the point of view of an earthbound observer, primary motion is perceived as Earth remaining at rest while the surrounding celestial sphere and everything on it (including the zodiacal belt) rotate about Earth's line of poles.

Secondly, the division of the zodiac into 12 signs is related to Sun's yearly journey along the celestial sphere. In this regard, suppose that we (at a fixed location) were to compare various

astrological charts, all for the same time of day, but for different days. As the days go forward in time, we would see chart-wise that Sun moves forward through the signs, which implies that it changes its house location in ascending numerical order. Other planets in direct motion move in the same way. This apparent movement of the planets along the zodiac is associated with Earth's orbital motion about Sun, and it is called **secondary motion**.

## 2. SOME NOTIONS

### 2.1 Ecliptic coordinates

From the point of view of an earthbound observer, the ecliptic is Sun's annual path along the celestial sphere. This path is nearly a great circle. The plane of the ecliptic is inclined at a slowly varying angle (currently about  $23^{\circ} 26' 09''$ ) relative to the celestial equatorial plane (which is the same as Earth's equatorial plane). The line of intersection between these planes passes through Earth's center, and it connects the March and September equinox points.

The **ecliptic coordinate system** enables us to specify the location of any point of the celestial sphere in terms of pertinent values of longitude and latitude. **Ecliptic longitude** is essentially angular distance measured along the ecliptic, going from  $0^{\circ}$  to  $360^{\circ}$  as we go eastward from Aries  $0^{\circ}$ . **Ecliptic latitude** is angular distance (along the celestial sphere) from the ecliptic, going from  $0^{\circ}$  to  $+90^{\circ}$  as we go perpendicularly northward and going from  $0^{\circ}$  to  $-90^{\circ}$  as we go perpendicularly southward.

In the tropical zodiac, Aries  $0^{\circ}$  is the March equinox point. As a result of Earth's axial precession, the equinoxes slowly move westward along the ecliptic (that is, backward along the zodiac). Consequently, tropical Aries  $0^{\circ}$  is usually not the same as sidereal Aries  $0^{\circ}$ . The angular difference between sidereal Aries  $0^{\circ}$  and tropical Aries  $0^{\circ}$  is called the **ayanāṃśa**. Adding the *ayanāṃśa* to a sidereal ecliptic longitude yields its equivalent tropical ecliptic longitude. Note that Earth's axial precession does not affect ecliptic latitude, and so the tropical ecliptic latitude equals the sidereal ecliptic latitude.

We will be using the *ayanāṃśa* called 'True Chitrā  $0^{\circ}$  Libra', which is based on taking the fixed star *Chitrā* (Spica) to always be at sidereal Libra  $0^{\circ}$ . Consequently, sidereal Aries  $0^{\circ}$  is longitudinally opposite *Chitrā*.

TABLE 2.1 shows how ecliptic longitude is related to sign longitude. As an example, suppose that Moon has a sign longitude of Leo 24° 55'. From the table, we find that Leo 0° has an ecliptic longitude of 120°. It follows that Moon's ecliptic longitude here is  $120^\circ + 24^\circ 55' = 144^\circ 55'$ .

Sun's ecliptic latitude is 0° exactly. For each of the other planets, the ecliptic latitude varies along the zodiacal belt between some extreme negative (southern) value and some extreme positive (northern) value.

## 2.2 Degree-based aspects

An **aspect** between two astrological entities exists whenever the difference between their ecliptic longitudes is in the vicinity of some signature value carrying astrological meaning.

TABLE 2.2a presents the signature separations for aspects that each involve an integer multiple of 30°. An aspect is said to be exact when it has its signature value. For an aspect between planets, we will follow astrologer Mychal A. Bryan by taking the margin of inexactness to be 07° in order for the aspect to be valid. See TABLE 2.2b for pertinent details.

Aspects show interactions between astrological entities. An aspect is either 'soft' or 'hard'. A **soft aspect** indicates a harmonious relationship between the two entities in question. For a soft aspect, little or no effort must be made for the two entities to cooperate (that is, to work together for a common purpose). A **hard aspect** indicates an inharmonious relationship between the two entities in question. For a hard aspect, suitable effort must be made for the two entities to cooperate.

A **conjunction** is a major aspect that is formed whenever two entities are about 0° apart. It usually involves two entities that have almost the same degree in the same sign. A conjunction is a blending of the agendas of the two entities involved, and it is soft or hard according to the degree of compatibility between the two agendas.

A **duodecile** (or **semi-sextile**) is a minor aspect that is formed whenever two entities are about 30° apart. It usually involves two entities that have almost the same sign degree in signs that are next-door neighbors. The two signs of a duodecile have different genders, different elements, and different modalities. Element-wise, they involve duos of lesser compatible elements. Fire and air do not work so well with earth and water. The difference of gender, element, and modality, together with the lesser compatibility of elements, indicate that the two entities share no common ground (that is, shared beliefs or interests) thereby making this aspect hard. Nevertheless, this aspect involves next-door neighbors, and so the two entities can potentially build common ground by thinking creatively and making suitable adaptations.

A **sextile** is a major aspect that is formed whenever two entities are about 60° apart. It usually involves two entities that have almost the same sign degree in signs that are two neighbors away from each other. The two signs of a sextile have the same gender, but different elements and different modalities. Element-wise, they are either a fire-air duo or an earth-water duo. Fire and air support each other; earth and water support each other. The sameness of gender and the compatibility of elements indicate that the two entities share substantial common ground, thereby making this aspect soft.

A **square** is a major aspect that is formed whenever two entities are about 90° apart. It usually involves two entities that have almost the same sign degree in signs that are three neighbors away from each other. The two signs of a square have different genders and different elements, but the same modality. Element-wise, they involve duos of lesser compatible elements. The sameness of modality, together with the difference of gender and lesser compatibility of elements, indicate that the two entities share little common ground, thereby making this aspect hard. A square often indicates a call for one entity to bring its agenda into line with the agenda of the other entity.

A **trine** is a major aspect that is formed whenever two entities are about 120° apart. It usually involves two entities that have almost the same sign degree in signs that are four neighbors away from each other. The two signs of a trine have the same gender, the same element, but different modalities. The sameness of gender and element indicates that the two entities share substantial common ground, thereby making this aspect soft.

A **quincunx** is a minor aspect that is formed whenever two entities are about 150° apart. It usually involves two entities that have almost the same sign degree in signs that are five neighbors away

from each other. The two signs of a quincunx have different genders, different elements, and different modalities. Element-wise, they involve duos of lesser compatible elements. The difference of gender, element, and modality and the lesser compatibility of elements indicate that the two entities share no common ground, thereby making this aspect hard.

An **opposition** is a major aspect that is formed whenever two entities are about 180° apart. It usually involves two entities that have almost the same sign degree in signs that are six neighbors away from each other. The two signs of an opposition have the same gender, compatible elements, and the same modality. The adjective ‘opposite’ can mean ‘being the other of two complementary things’ or ‘being contrary to one’s interests or welfare’. In this regard, the two entities here are two halves that are somehow not acting as the whole that they are meant to be, and so an opposition indicates a call to harmonize these two competing interests.

FIGURE 2.2 presents my natal chart in terms of sidereal whole-sign houses. The major planet-to-planet aspects in my natal chart are the Moon-Jupiter sextile, the Moon-Saturn sextile, the Mercury-Saturn square, the Venus-Mars square, the Sun-Jupiter trine, the Sun-Saturn trine, the Jupiter-Saturn trine, and the Moon-Sun opposition. The minor planet-to-planet aspects in my natal chart are the Moon-Mercury quincunx and the Mercury-Jupiter quincunx.

For learning purposes, let’s consider how to see the sextile relationship between Moon (at Leo 24° 55’) and Saturn (at Libra 27° 54’) in my natal chart. Firstly, Moon and Saturn have almost the same sign degree in signs that are two neighbors away from each other. Secondly, the difference between their sign degrees is  $27^{\circ} 54' - 24^{\circ} 55' = 02^{\circ} 59'$ , which does not exceed 07° (our margin of inexactness). That’s it! Another way to see the sextile here is as follows. Firstly, in terms of ecliptic longitudes, Moon is at 144° 55’ and Saturn is at 207° 54’. Secondly, the difference between their ecliptic longitudes is  $207^{\circ} 54' - 144^{\circ} 55' = 62^{\circ} 59'$ . Thirdly, the deviation of this

difference from the sextile signature value is  $62^{\circ} 59' - 60^{\circ} = 02^{\circ} 59'$ , which does not exceed  $07^{\circ}$  (our margin of inexactness).

In dealing with aspects, we will be using the notion of ‘aspect copies’. According to this notion, each planet projects a virtual copy of itself to each point that is at  $30^{\circ}$ ,  $60^{\circ}$ ,  $90^{\circ}$ ,  $120^{\circ}$ ,  $150^{\circ}$ , and  $180^{\circ}$  away. Each aspect copy at  $30^{\circ}$  away has duodecile qualities, each aspect copy at  $60^{\circ}$  away has sextile qualities, each aspect copy at  $90^{\circ}$  away has square qualities, and so on.

For learning purposes, let’s consider the sextile relationship between Moon (at Leo  $24^{\circ} 55'$ ) and Saturn (at Libra  $27^{\circ} 54'$ ) in my natal chart. Moon projects a sextile copy to the point Libra  $24^{\circ} 55'$ , and so Saturn experiences the sextile as a conjunction in Libra between Moon’s sextile copy and itself. Moreover, Saturn projects a sextile copy to Leo  $27^{\circ} 54'$ , and so Moon experiences the sextile as a conjunction in Leo between itself and Saturn’s sextile copy.

An angle (that is, the Ascendant, the Descendant, the Midheaven, or the Imum Coeli) does not project aspect copies. Therefore, whenever there is an aspect between a planet and an angle, the planet is the initiator of the aspect. For such an aspect, we will take the margin of inexactness to be  $07^{\circ}$  in order for the aspect to be valid.

We may extend the notion of aspects to signs and houses. As an example of a sign-based aspect, two signs have a trine relationship if each one is four neighbors away from the other. As an example of a house-based aspect, two houses have a square relationship if each one is three neighbors away from the other.

## 2.3 Exact and close aspects

Regarding angular separation, an aspect is either exact or close. Practically speaking, an **exact aspect** occurs when the two entities in question share the same degree, minute, and second of arc in their respective signs according to the aspect’s definition. A **close aspect** occurs when the two entities in question deviate from the aspect’s signature angular separation within the margin of inexactness.

A close aspect is said to be **applying** if the pertinent angular separation is decreasing toward the signature value. The model applying aspect involves a direct-motion planet that has a lower sign degree than a slower entity. In this case, the planet’s aspect copy is moving toward the slower entity. Here we say that the faster planet is applying to an aspect with the slower entity. An aspect that is applying becomes more potent as it approaches exactness.

A close aspect is said to be **separating** if the pertinent angular separation is increasing from the signature value. The model separating aspect involves a direct-motion planet that has a higher sign degree than a slower entity. In this case, the planet’s aspect copy is moving away from the slower planet. Here we say that the faster planet is separating from an aspect with the slower entity. An aspect that is separating becomes less potent as the aspect leaves exactness.

If the faster planet is applying to or separating from a slower entity that is ahead of it in the zodiac, then the aspect is said to be **sinister**. If the faster planet is applying to or separating from a slower entity that is behind it in the zodiac, then the aspect is said to be **dexter**.

TABLE 2.3 presents the average longitudinal angular speed of each classical planet as it moves along the celestial sphere. Arranged from slowest to fastest, these planets are: Saturn, Jupiter, Mars, Sun, Venus, Mercury, and Moon. This speed hierarchy is called the **Chaldean order** of planets, and it may be used to determine whether an aspect is applying or separating.

In the *Tajika* tradition of astrology (which is a blending of Indian and Perso-Arabic astrological traditions), applying and separating aspects are two types of planetary yogas. The Sanskrit noun **yoga** means ‘joining’. An applying aspect is called an *ithasala yoga*, while a separating aspect is called an *isharafa yoga*. The Sanskrit word *ithasala* comes from the Arabic noun *ittiṣāl*, which means ‘making contact’. The Sanskrit word *isharafa* comes from the Arabic noun *inṣirāf*, which means ‘turning away’.

Yogas are not limited to the joining of two planets. Let’s consider two yogas that each involve the joining of three planets. A **nakta yoga** is formed whenever a faster third planet is in a major aspect with each of two slower planets having no major aspect between them. The Sanskrit word *nakta* comes from the Arabic noun phrase *naql an-nūr*, which means ‘translation of light’. A **yamaya yoga** is formed whenever a slower third planet is in a major aspect with each of two faster planets having no major aspect between them. The Sanskrit word *yamaya* comes from the Arabic noun phrase *jam<sup>s</sup> an-nūr*, which means ‘collection of light’. In each of these yogas, the third planet serves as a link between the two planets having no major aspect between them. Each of these three-planet yogas indicates an event that is facilitated by a third party.

## 2.4 Essential dignity

Each classical planet has some level of **essential dignity**, which is a measure of how ‘good’ (full of merit) or ‘bad’ (flawed) the planet is. If a planet is dignified (that is, having high essential dignity), then it represents someone/something that is contextually good, is helpful, or feels/functions well. If a planet is debilitated (that is, having low essential dignity), then it represents someone/something that is contextually bad, is harmful, or feels/functions unwell.

The essential dignity of a classical planet depends on how well it can ‘be itself’ in the sign hosting it. A planet has its highest level of essential dignity whenever it is in **domicile** (that is, in a sign that it rules). A planet in domicile is like a person who can ‘be themselves’ because they are in their own home. A planet has its lowest level of essential dignity whenever it is in **exile** (that is, in a sign that is opposite to one it rules). A planet in exile is like a person in a stranger’s home – they can ‘be themselves’ to the extent that they comply with the regulations of their host.

If a planet is not in domicile or exile, then it has some intermediate level of essential dignity. Let’s consider two intermediate levels: congenial and uncongenial. The adjective ‘congenial’ means ‘suitable to one’s nature or needs’. In order to explore the two intermediate levels, let’s consider the four triplicities. See TABLE 2.4a for pertinent details.

The fire and air triplicities are opposites because they contain each other’s opposite signs. Similarly, the earth and water triplicities are opposites. Note that one meaning of the adjective ‘opposite’ is ‘being the other of two complementary things’. In this regard, opposites are two halves of a whole. Fire and air support each other; earth and water support each other.

It is convenient here to view Sun and Moon as the respective masculine and feminine expressions of a planet called *Luminary*. Each planet is then associated with two triplicities according to TABLE 2.4a. For example, Mars is associated with the fire triplicity because Mars-ruled Aries belongs to that triplicity. Mars is also associated with the water triplicity because Mars-ruled Scorpio belongs to that triplicity.

The fire and air triplicities are opposites; the earth and water triplicities are opposites. Here I use these notions to invent a concept that I will refer to as ‘**congeniality by triplicity**’:

- A planet is somewhat dignified whenever it is in a sign belonging to one of its triplicities. Here we say that the hosting sign is congenial to the occupying planet.
- A planet is somewhat debilitated whenever it is in a sign belonging to a triplicity that is opposite its own. Here we say that the hosting sign is uncongenial to the occupying planet.

A planet in a congenial sign is like a person who can somewhat ‘be themselves’ because they are in a welcoming home.

On applying congeniality by triplicity to Luminary, Mars, and Jupiter, we see that they are each somewhat dignified in signs of the fire and water triplicities. Moreover, they are each somewhat debilitated in signs of the air and earth triplicities. In other words, Luminary, Mars, and Jupiter find congeniality in one another’s signs, but find uncongeniality in the signs of Mercury, Venus, and Saturn. On applying congeniality by triplicity to Mercury, Venus, and Saturn, we find that they find congeniality in one another’s signs, but find uncongeniality in the signs of Luminary, Mars, and Jupiter.

Whenever a planet is in domicile, it is in one of its triplicity signs. Whenever a planet is in exile, it is in a sign belonging to a triplicity that is opposite its own. It follows that we may view domicile and exile as special cases of congeniality by triplicity. TABLE 2.4b uses a percentage ranking

system to present the level of essential dignity for each classical planet according to congeniality by triplicity.

In addition to essential dignity based on congeniality by triplicity, a classical planet may have essential dignity because of exaltation or depression. A planet in **exaltation** (that is, in a sign that allows an elevated expression) has increased influence and is held in high regard. A planet in **depression** (that is, in the sign that is opposite to its exaltation sign) has diminished influence and is held in low regard. TABLE 2.4c presents the exaltation and depression signs for each classical planet. Note that Gemini, Leo, Sagittarius, and Aquarius are not involved in exaltation and depression.

TABLE 2.4b uses a percentage ranking system to present the level of essential dignity for each classical planet according to congeniality by triplicity. If a classical planet is in Gemini, Leo, Sagittarius, or Aquarius, then its percentage level of essential dignity is simply its table value. If the planet is in any of the other signs, then we will:

- Add 100% to the table value and then average if the planet is in exaltation;
- Add 10% to the table value and then average if the planet is in depression.

By averaging here, we get a value that is no lower than 10% and no higher than 100%. As an example, consider a case in which Venus is in Pisces. Because Pisces is uncongenial triplicity-wise to Venus, we get the table value of 50% essential dignity. But Venus is exalted in Pisces, and so we get  $\frac{1}{2}(50\% + 100\%) = 75\%$  as the overall essential dignity for Venus in Pisces.

In exploring intermediate levels of essential dignity, we have used a notion from *Jyotiṣa*, which is the Indian tradition of astrology. The concept of congeniality by triplicity yields results that agree considerably (but not completely) with results coming from the *Jyotiṣa* concept of planetary friends and enemies.

Here is an interesting note on exaltations in terms of sign-based aspects. Sun-ruled Leo makes a trine with Sun’s exaltation sign Aries. Jupiter-ruled Pisces makes a trine with Jupiter’s exaltation

sign Cancer. Saturn-ruled Aquarius makes a trine with Saturn’s exaltation sign Libra. Mercury-ruled Gemini makes a square with Mercury’s exaltation sign Virgo. Moon-ruled Cancer makes a sextile with Moon’s exaltation sign Taurus. Venus-ruled Taurus makes a sextile with Venus’s exaltation sign Pisces. Mars-ruled Scorpio makes a sextile with Mars’s exaltation sign Capricorn.

## 2.5 Accidental strength

Each classical planet has **accidental strength**, which is a measure of its ability to take advantage of external factors in order to achieve its agenda (that is, things to be done). The adjective ‘accidental’ here means ‘occurring according to circumstances’. Having high accidental strength means that circumstances are to one’s advantage, and so circumstances open the way for success. Having low accidental strength means that circumstances are not to one’s advantage, and so achieving success is a demanding effort.

One determining factor of a planet’s accidental strength is the strength of the house hosting it. In his 1647 book *Christian Astrology*, the English astrologer William Lilly ranked the houses from strongest to weakest as follows: 1, 10, 7, 4, 11, 5, 9, 3, 2, 8, 6, 12. A simplified version of this ranking is presented in TABLE 2.5a.

The primary consideration for Lilly’s ranking is how the houses are connected to H1 (the 1st House) by aspect. With respect to H1, the 10th and 4th Houses are each in square (which is a hard major aspect), the 7th House is in opposition (which is a hard major aspect), the 11th and 3rd Houses are each in sextile (which is a soft major aspect), the 5th and 9th Houses are each in trine (which is a soft major aspect), the 2nd and 12th Houses are each in duodecile (which is a minor aspect), and the 8th and 6th Houses are each in quincunx (which is a minor aspect).

Another consideration for Lilly’s ranking is whether a house is angular, succedent, or cadent. A planet in an **angular house** takes effective action quickly. The 1st, 4th, 7th, and 10th Houses are angular. A planet in a **succedent house** takes effective action at a relatively good pace. The 2nd, 5th, 8th, and 11th Houses are succedent. A planet in a **cadent house** takes effective action at a very slow pace or not at all. The 3rd, 6th, 9th, and 12th Houses are cadent. Still another consideration for Lilly’s ranking is whether a house is above or below the horizon.

In Section 1.5, we mentioned the notion of planetary joys, which says that each classical planet has an affinity for a particular house where it functions naturally. TABLE 2.5b presents the house of joy for each classical planet.

TABLE 2.5a uses a percentage ranking system to present the level of accidental strength for each house according to its connection to H1. It makes sense that each classical planet gains additional accidental strength in its house of joy. If a classical planet is in its house of joy, then we will:

- Add 100% to the table value and then average.

By averaging here, we get a value that is no lower than 62.5% and no higher than 100%. As an example, consider a case in which Mars is in the 6th House. The 6th House has the table value of 25% accidental strength. But Mars has its joy in the 6th House, and so we get  $\frac{1}{2}(25\% + 100\%) = 62.5\%$  as the overall accidental strength for Mars in the 6th House.

## 2.6 Dispositors

If Planet *A* is in the domicile of Planet *B*, then Planet *B* is said to be the **dispositor** of Planet *A*. Another way to express the situation here is to say that Planet *B* disposes Planet *A*. In this context, the verb ‘dispose’ means ‘to determine the outcome of’. For example, if Venus is in Mercury-ruled Gemini, then Mercury is the dispositor of Venus. In other words, Mercury disposes Venus.

If Planet *A* is in the domicile of Planet *B*, then Planet *A* is in a sign where Planet *B* has a high level of essential dignity. In this regard, we may extend the definition of a dispositor to include exaltation. More specifically, if Planet *A* is in sign *S*, then its dispositors are the domicile ruler of sign *S* and the planet that is exalted in sign *S*. For example, if Mars is in Pisces, then its dispositors are Jupiter (the domicile ruler) and Venus (the exaltation ruler). We will refer to the dispositor by domicile as the **primary dispositor**.

In his blog post *The Essential Role of Dispositors in Horary* (13 March 2021), astrologer Anthony Louis states that:

“The theory behind dispositorship is anthropomorphic and straightforward. If I am a planet visiting your home, then I am dependent on you for the resources at my disposal to accomplish my aims.”

If Planet *B* disposes Planet *A*, then this situation indicates that Planet *A* is subject to Planet *B*.

## 2.7 Some Hellenistic lots

The noun ‘lot’ may be used to refer to a divinatory tool. The Hellenistic tradition of astrology made use of a number of calculated points as lots. The two most important Hellenistic lots involve the Ascendant, Sun, and Moon. The **Lot of Fortune** (or **Part of Fortune**) is an astrological point that is calculated according to the formula

$$LFo = Asc + Moon - Sun .$$

The **Lot of Spirit** (or **Part of Spirit**) is an astrological point that is calculated according to the formula

$$LSp = Asc + Sun - Moon .$$

The quantities in these formulas are the pertinent ecliptic longitudes.

Intrinsically speaking, Sun refers to activity that follows from one’s volition, while Moon refers to things that are beyond willful control (and hence things to which one must submit). Let’s use these notions to interpret the formulas for the Lots of Fortune and Spirit.

The Greek noun *túkhē* (fortune) refers to luck, which is the occurrence of favorable or unfavorable events that are beyond willful control. Regarding the Lot of Fortune, Sun refers to willed efforts, and Moon refers to good luck. Therefore, the mathematical difference ‘Moon minus Sun’ figuratively represents traveling the distance from one’s willed efforts (Sun) to good luck (Moon). Adding this difference to the Ascendant makes the journey pertain to oneself specifically. In summary, the Lot of Fortune indicates how and where one can attract good luck to support their efforts.

The Greek noun *daimōn* (spirit) refers to a divine guardian spirit. Regarding the Lot of Spirit, Moon refers to latent, inborn abilities, and Sun represents willed display. Therefore, the mathematical difference ‘Sun minus Moon’ figuratively represents traveling the distance from one’s abilities as being potential (Moon) to one’s abilities as being realized (Sun). Adding this difference to the Ascendant makes the journey pertain to oneself specifically. In summary, the Lot of Spirit indicates how and where one can wholesomely develop their life potential.

The **Lot of Retribution** is an astrological point that is calculated according to the formula

$$LRe = Asc + Saturn - LFo ,$$

where the quantities in this formula are the pertinent ecliptic longitudes. The Greek noun *némesis* (retribution) refers to punishment administered in return for wrongdoing. The Lot of Retribution refers to that which brings a justly deserved penalty. The mathematical difference ‘*Saturn* minus *LFO*’ figuratively represents traveling the distance from good luck (Lot of Fortune) to negative limitations (Saturn). Adding this difference to the Ascendant makes the journey pertain to oneself specifically. In summary, the Lot of Retribution indicates how and where one can meet their downfall.

As a calculation example, let’s determine my natal Lots of Fortune, Spirit, and Retribution. In my natal chart (FIGURE 1.6), the Ascendant is at Gemini 06° 24’ 11”, Sun is at Aquarius 24° 08’ 37”, Moon is at Leo 24° 55’ 32”, and Saturn is at Libra 27° 54’ 33”. On making use of TABLE 2.1, we find that

$$\begin{aligned} Asc &= 60^\circ + 06^\circ 24' 11'' = 66^\circ 24' 11'' , \\ Sun &= 300^\circ + 24^\circ 08' 37'' = 324^\circ 08' 37'' , \\ Moon &= 120^\circ + 24^\circ 55' 32'' = 144^\circ 55' 32'' , \\ Saturn &= 180^\circ + 27^\circ 54' 33'' = 207^\circ 54' 33'' \end{aligned}$$

are the pertinent ecliptic longitudes.

For the Lot of Fortune, we get

$$\begin{aligned} LFO &= Asc + Moon - Sun = 66^\circ 24' 11'' + 144^\circ 55' 32'' - 324^\circ 08' 37'' \\ &= -112^\circ 48' 54'' . \end{aligned}$$

Here we have encountered an angle that lies outside the customary range of values for ecliptic longitude (which is from 0° up to 360°). In such cases, we add or subtract 360° as many times as necessary in order to get an angle that lies within the customary range. In this regard, we find that

$$LFO = -112^\circ 48' 54'' \equiv -112^\circ 48' 54'' + 360^\circ = 247^\circ 11' 06'' = 240^\circ + 07^\circ 11' 06'' ,$$

which is Sagittarius 07° 11’ 06” according to TABLE 2.1.

For the Lot of Spirit, we get

$$\begin{aligned} LSp &= Asc + Sun - Moon = 66^\circ 24' 11'' + 324^\circ 08' 37'' - 144^\circ 55' 32'' \\ &= 245^\circ 37' 16'' = 240^\circ + 05^\circ 37' 16'' , \end{aligned}$$

which is Sagittarius 05° 37’ 16” according to TABLE 2.1.

For the Lot of Retribution, we get

$$\begin{aligned} LRe &= Asc + Saturn - LFO = 66^\circ 24' 11'' + 207^\circ 54' 33'' - 247^\circ 11' 06'' \\ &= 27^\circ 07' 38'' = 0^\circ + 27^\circ 07' 38'' , \end{aligned}$$

which is Aries 27° 07’ 38” according to TABLE 2.1.

## 3. SOME HORARY ASTROLOGY

### 3.1 Bryan's horary-astrology rubric

**Horary astrology** is based on the belief that the answer to a query can be determined by casting an astrological chart for the query's time and place of birth. This chart is called a **horary chart**, and the person who is primarily asking the question is called the **querent**. The person(s) or thing(s) that are asked about are called the **quesited**. The query's time of birth is the instant when the querent communicates their query to the astrologer. The query's place of birth is the querent's location when they communicate their query to the astrologer.

In his book *Predictive Astrology Textbook*, astrologer Alexey Borealis presents criteria that show the querent's matter of concern. In this regard, Moon's primary dispositor indicates what is on the querent's mind with regard to the query. Moreover, Moon's house location shows an area of life that is of great interest to the querent. We will use these two criteria to clarify the query.

Each whole-sign house of an astrological chart is represented by its **house lord**, which is the planet that rules the sign tied to the house in question. For example, if Saturn-ruled Aquarius is tied to the whole-sign 9th-House, then Saturn is the 9th-House lord.

In horary astrology, the **querent's significator** is usually the lord of the 1st House (which refers to the querent). In some cases, we may take the querent's significator to be a planet in the 1st House. The **quesited's significator** is the lord of the house that refers to the quesited. In most cases, Moon is a co-significator of the querent, but there are some cases in which it is the quesited's significator instead.

In order to get the query's answer, we will apply the following **horary-astrology rubric**:

- **STEP #H1:** Identify the querent's significator. Assess its essential dignity and accidental strength.
- **STEP #H2:** Identify the quesited's significator. Assess its essential dignity and accidental strength.
- **STEP #H3:** Assess Moon's essential dignity and accidental strength.
- **STEP #H4:** Give thought to other noteworthy considerations. One such consideration could be occupants of the respective houses of the querent and the quesited.
- **STEP #H5:** Look for major aspects among the querent, the quesited, and Moon.
- **STEP #H6:** Make a judgment.

This rubric (that is, set of procedural rules) is presented by astrologer Mychal A. Bryan in his books *Mastering Traditional Astrology* and *Horary Astrology & the Natal Promise*.

The horary-astrology rubric calls us to make use of the following tools of chart analysis:

- **Essential dignity:** This tool shows a significator's quality. Is the significator good or bad? Is it intrinsically helpful or harmful? Does it feel/function well or unwell?
- **Accidental strength:** This tool shows a significator's ability to take advantage of external factors in order to achieve its agenda. Will the significator triumph? Will it persist?
- **Dispositors:** This tool shows a significator's dependence on another entity. What are the circumstances under which the significator is operating? Is the significator under another's control?
- **Exact aspects:** This tool shows events in which two significators come into contact with each other. If a major aspect is inexact by  $X$  degrees, then it indicates that the two pertinent entities will come together in  $X$  time units (whether hours, days, weeks, months, or years).
- **Close aspects:** This tool uses close aspects to show a relationship between two significators that occurs over a period of time. This relationship could be a long-term connection, a long-term influence, or a process.

These tools are often adequate for answering the query.

Each classical planet serves as the representative of its house(s) via its accidental role as the house lord. Moreover, each classical planet is the natural representative of some subset of persons, places, or things. We will follow astrologer Mychal A. Bryan by interpreting what a planet is doing firstly as an accidental representative and secondly as a natural representative.

As declared in Section 1.6, we will be using the sidereal zodiac and the whole-sign house system as our foundation, while overlaying Porphyry houses as nuances.

**IMPORTANT COMMENTS:** No matter how good or bad your situation may be, seek divine help through prayerful affirmations and other suitable magical work. Be mindful that the power of God is within you, and so you can transcend any circumstance, habit, or personality trait. Tap into your divine power by cultivating good character and wisdom.

## 3.2 A 3rd-House query: A possible trip

Back in the fall of 2020, I considered driving my car to New Orleans, Louisiana in order to visit my friend JRM around his birthday in November. On Friday, 23 October 2020 at 01:38 pm, EDT, the following question formed in my mind:

**Query:** I am considering visiting the New Orleans metro area around the time of my friend JRM's birthday. Would making this visit result in good fortune for me?

FIGURE 3.2 presents the pertinent horary chart in terms of sidereal whole-sign houses. The *ayanāmśa* here is  $24^{\circ} 07' 34''$  according to True Chitrā  $0^{\circ}$  Libra.

Let's use Moon to clarify the query. Firstly, Moon's primary dispositor indicates what is on the querent's mind with regard to the query. For Moon in Capricorn, its primary dispositor is Saturn. As the lord of Aquarius 3rd House (short-distance travel) and Capricorn 2nd House (supportive persons or things; portable property), Saturn refers to my concern about my car being supportive to my proposed drive. Secondly, Moon's house location shows an area of life that is of great interest to the querent. Moon lies in the intersection of Capricorn 2nd House (supportive persons or things; portable property) and PH1 (the querent and their physical vehicle). This house location indicates that the condition of my car is a matter of importance.

Now that we have clarified the query, let's use the horary-astrology rubric to get the answer.

**STEP #H1:** Firstly, let's identify the querent's significator. The querent (me) is associated with the 1st House. Because Jupiter-ruled Sagittarius is tied to the 1st House, Jupiter is the 1st-House lord. Secondly, let's assess the essential dignity and accidental strength of the querent's significator:

**Jupiter in Sagittarius 1st House:** Sagittarius is Jupiter's domicile, thereby allowing 100% essential dignity. Therefore, Jupiter is in good condition. Jupiter lies in the intersection of Sagittarius 1st House and PH1, both houses referring to the querent. The 1st House and PH1 each allow 100% accidental strength, and so Jupiter's overall accidental strength is  $\frac{1}{2}(100\% + 100\%) = 100\%$ . Therefore, circumstances are to Jupiter's advantage.

I (the querent) am in good condition, and circumstances are to my advantage.

**STEP #H2:** Firstly, let's identify the quesited's significator. The quesited pertains to my proposed trip, which is associated with the 3rd House (short-distance travel). Because Saturn-ruled Aquarius

is tied to the 3rd House, Saturn is the 3rd-House lord and hence the quesited's significator. Secondly, let's assess the essential dignity and accidental strength of the quesited's significator:

**Saturn in Capricorn 2nd House:** Capricorn is Saturn's domicile, thereby allowing 100% essential dignity. Therefore, Saturn is in good condition. Saturn lies in the intersection of Capricorn 2nd House (supportive persons or things) and PH1 (the querent and their physical vehicle). The 2nd House allows 50% accidental strength, while PH1 allows 100% accidental strength, and so Saturn's overall accidental strength is  $\frac{1}{2}(50\% + 100\%) = 75\%$ . Therefore, circumstances are to Saturn's advantage.

My proposed drive (the quesited) is a good plan, and circumstances favor it.

**STEP #H3:** The query clarification suggests that Moon represents my car. Note that Moon is a co-significator of the querent, and it is the natural representative of short-term travel. Let's assess Moon's essential dignity and accidental strength:

**Moon in Capricorn 2nd House:** Capricorn is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. Moon lies in the intersection of Capricorn 2nd House (supportive persons or things; portable property) and PH1 (the querent and their physical vehicle). The 2nd House allows 50% accidental strength, while PH1 allows 100% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(50\% + 100\%) = 75\%$ . Therefore, circumstances are to Moon's advantage.

My car is somewhat in good condition, and circumstances are to its advantage.

**STEP #H4:** Let's give thought to other noteworthy considerations. There is nothing in this regard.

**STEP #H5:** Let's look for major aspects among the querent, the quesited, and Moon. Jupiter (the querent) is applying to a conjunction with Saturn (the quesited):

**Jupiter-Saturn conjunction:** As the lord of Pisces 4th House (comfort and security) and Sagittarius 1st House (the querent), Jupiter refers to me as someone seeking safety. As the lord of Aquarius 3rd House (short-distance travel) and Capricorn 2nd House (supportive persons or things; portable property), Saturn refers to my car as being supportive to my proposed drive. The applying conjunction here indicates an opportunity for me to have a safe trip in my car.

Taking my proposed drive can result in good fortune for me.

**STEP #H6:** I am the astrologer, and here is my judgment. Apart from my car being somewhat in good condition, my proposed drive seems favorable. Unless I give attention to my car being roadworthy, I will not make the proposed drive.

**COMMENTS:** My chart analysis here is somewhat the product of hindsight. At the time when I cast the chart for the query here, I didn't understand what it was telling me. Nevertheless, I felt uncomfortable about driving out of town, and so I remained in Atlanta around the time of JRM's birthday. It was during that time that my car battery failed and needed to be replaced.

### 3.3 A 6th-House query: My battle against diabetes

In early 2022, I was given the bad news of having a condition of type-2 diabetes. After making many prayerful affirmations and changing my diet, I have come to the point of moderating my blood sugar without the use of medications. On Wednesday, 29 January 2025 at 08:00 am, EST, the following question formed in my mind:

**Query:** Is my body mending from diabetes?

FIGURE 3.3 presents the pertinent horary chart in terms of sidereal whole-sign houses. The *ayanāmsā* here is 24° 11' 35" according to True Chitrā 0° Libra.

Let's use Moon to clarify the query. Firstly, Moon's primary dispositor indicates what is on the querent's mind with regard to the query. For Moon in Capricorn, its primary dispositor is Saturn. As the lord of Aquarius 2nd House (supportive persons or things) and Capricorn 1st House (the querent's physical body and its health), Saturn refers to my concern about my physical body being supportive to good health. Secondly, Moon's house location shows an area of life that is of great interest to the querent. Moon lies in the intersection of Capricorn 1st House (the querent's physical body and its health) and PH12 (chronic illness). This house location indicates that I am concerned about my diabetes condition.

Now that we have clarified the query, let's use the horary-astrology rubric to get the answer.

**STEP #H1:** Firstly, let's identify the querent's significator. The querent (me) is associated with the 1st House. Because Saturn-ruled Capricorn is tied to the 1st House, Saturn is the 1st-House

lord and hence the querent's significator. Secondly, let's assess the essential dignity and accidental strength of the querent's significator:

**Saturn in Aquarius 2nd House:** Aquarius is Saturn's domicile, thereby allowing 100% essential dignity. Therefore, Saturn is in good condition. Saturn lies in the intersection of Aquarius 2nd House (supportive persons or things) and PH1 (the querent's physical body and its health). The 2nd House allows 25% accidental strength, while PH1 allows 100% accidental strength, and so Saturn's overall accidental strength is  $\frac{1}{2}(25\% + 100\%) = 62.5\%$ . Therefore, circumstances are to Saturn's advantage.

I (the querent) am in good condition, and circumstances favor my body to be healthy.

**STEP #H2:** Firstly, let's identify the quesited's significator. The quesited pertains to my diabetes condition, which is associated with the 12th House (chronic illness). Because Jupiter-ruled Sagittarius is tied to the 12th House, Jupiter is the 12th-House lord and hence the quesited's significator. Diabetes is a chronic condition that is primarily linked to issues with the pancreas. In medical astrology, Jupiter refers to the pancreas. Secondly, let's assess the essential dignity and accidental strength of the quesited's significator:

**Jupiter in Taurus 5th House:** Taurus is uncongenial to Jupiter, thereby allowing 50% essential dignity. Therefore, Jupiter is somewhat in good condition. Jupiter lies in the intersection of Taurus 5th House (overdoing pleasure) and PH4 (comfort and security). The 5th House allows 50% accidental strength, while PH4 allows 100% accidental strength, and so Jupiter's overall accidental strength is  $\frac{1}{2}(50\% + 100\%) = 75\%$ . Therefore, circumstances are to Jupiter's advantage.

My diabetes condition (the quesited) is somewhat strong, and circumstances favor it to persist.

**STEP #H3:** Moon is a co-significator of the querent, and it is the natural representative of the digestive system. Let's assess Moon's essential dignity and accidental strength:

**Moon in Capricorn 1st House:** Capricorn is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. Moon lies in the intersection of Capricorn 1st House (the querent's physical body and its health) and PH12 (chronic illness). The 1st House allows 100% accidental strength, while PH12 allows 25% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(100\% + 25\%) = 62.5\%$ . Therefore, circumstances are to Moon's advantage.

In light of the foregoing, Moon refers to digestive illness. My digestive illness is somewhat strong essentially, and circumstances favor it to persist.

**STEP #H4:** Let's give thought to other noteworthy considerations. Sun, Moon, and Mercury lie in the intersection of Capricorn 1st House (the querent's physical body and its health) and PH12 (chronic illness). Sun is the natural representative of the will to survive. Moon is the natural representative of the digestive system, and I take it to refer here to digestive illness. Mercury is the natural representative of the nervous system, and I take it to refer here to the mild nerve damage (in my feet) that accompanies my diabetes condition. Moon and Mercury are each in conjunction with Sun, and their proximity to Sun is a visual representation of my diabetes condition as being burned up by my will to survive.

**STEP #H5:** Let's look for major aspects among the querent, the quesited, and Moon. Jupiter (the quesited) is separating from a dexter square with Saturn (the querent):

**Jupiter-Saturn square:** As the lord of Pisces 3rd House (illness persistence) and Sagittarius 12th House (chronic illness), Jupiter refers to persistence of my diabetes condition. Note that we are viewing the 3rd House here as the derived 4th House (comfort and security) with respect to the 12th House (chronic illness). As the lord of Aquarius 2nd House (supportive persons or things) and Capricorn 1st House (the querent's physical body and its health), Saturn refers to my physical body as being supportive to good health. The separating square here indicates that I am already bringing my diabetes condition into line with my agenda of having good bodily health.

Moon is applying to a sinister trine with Jupiter.

**Moon-Jupiter trine:** As previously found, Moon refers to my digestive illness. As the lord of Cancer 7th House (bodily death or bodily harm), Moon refers to the danger posed by my digestive illness. Moreover, as previously found, Jupiter refers to the persistence of my diabetes condition. The applying trine aspect here indicates an opportunity for my digestive illness to help my diabetes condition to continue its detrimental effects.

The gut microbiome is the variety of bacteria and other microorganisms living in the digestive tract. An unhealthy gut microbiome can lead to type-2 diabetes.

**STEP #H6:** I am the astrologer, and here is my judgment. My body is in good condition and is healing. My diabetes condition is gradually abating. In order to further my well-being, I must pay attention to my gut microbiome.

**COMMENTS:** On Thursday, 30 January 2025, I posed the query here to the *Yi-Jing* Oracle. The response was Hexagram 02 (KŪN, 'submissiveness'), which corresponds to astrological Moon. In medical astrology, Moon refers to the digestive system.

### 3.4 A 7th-House query: Racial relations in America

On Saturday, 15 February 2025 at 07:58 am, EST, the following question formed in my mind:

**Query:** What are African Americans to learn from our historical interactions with Caucasian Americans in this country?

FIGURE 3.4 presents the pertinent horary chart in terms of sidereal whole-sign houses. The *ayanāmsā* here is 24° 11' 42" according to True Chitrā 0° Libra.

African Americans are an American ethno-racial group consisting of partial or total ancestry from any of the dark-skinned racial groups of Africa. Caucasian Americans are an American ethno-racial group consisting of partial or total ancestry from any of the pale-skinned racial groups of Europe. Note that ethnic identity is based on cultural characteristics, while racial identity is based on physical characteristics. African Americans are the 'we' group to which I (the querent) belong. Therefore, the term 'querent' may be extended here to refer to African Americans as a group.

In the 1500s, European colonial powers began establishing plantations in the Americas in order to produce cash crops like sugar, tobacco, and cotton. These Caucasian powers turned to enslaving African captives in order to acquire the labor force in support of their plantation industry. Even after the 1865 abolition of slavery in this country, there has been a power differential in which Caucasian Americans have abused African Americans. A power differential is an imbalance of power in a relationship where one individual or group has more authority, influence, or control than another. In the presence of the aforementioned racial power differential, there cannot be racial harmony, which is the peaceful coexistence and respectful cooperation of people from diverse racial and ethnic backgrounds within a society.

Let’s use Moon to clarify the query. Firstly, Moon’s primary dispositor indicates what is on the querent’s mind with regard to the query. For Moon in Virgo, its primary dispositor is Mercury. As the lord of Gemini 5th House (personal interests) and Virgo 8th House (unwholesome communal influences), Mercury refers to my concern about unwholesome influences that have plagued the African-American community. Note that we are viewing the 8th House here as the derived 6th House (being subject to unwholesome influences) with respect to the 3rd House (community). Secondly, Moon’s house location shows an area of life that is of great interest to the querent. Moon lies in the intersection of Virgo 8th House (unwholesome communal influences) and PH7 (opponents). This house location indicates that I am greatly interested in how opponents have afflicted the African-American community.

Now that we have clarified the query, let’s use the horary-astrology rubric to get the answer.

**STEP #H1:** Firstly, let’s identify the querent’s significator. The querent (African Americans as an ethno-racial group) is associated with the 1st House. Because Saturn-ruled Aquarius is tied to the

1st House, Saturn is the 1st-House lord and hence the querent's significator. Secondly, let's assess the essential dignity and accidental strength of the querent's significator:

**Saturn in Aquarius 1st House:** Aquarius is Saturn's domicile, thereby allowing 100% essential dignity. Therefore, Saturn is in good condition. Saturn lies in the intersection of Aquarius 1st House and PH1, both houses referring to the querent's well-being. The 1st House and PH1 each allow 100% accidental strength, and so Saturn's overall accidental strength is  $\frac{1}{2}(100\% + 100\%) = 100\%$ . Therefore, circumstances are to Saturn's advantage.

African Americans (the querent) are in good condition, and circumstances favor them to further their well-being.

**STEP #H2:** Firstly, let's identify the quesited's significator. The quesited pertains to Caucasian Americans as an ethno-racial group, which is associated with the 7th House (someone else). Because Sun-ruled Leo is tied to the 7th House, Sun is the 7th-House lord and hence the quesited's significator. Secondly, let's assess the essential dignity and accidental strength of the quesited's significator:

**Sun in Aquarius 1st House:** Aquarius is Sun's exile, thereby allowing 10% essential dignity. Therefore, Sun is in bad condition. Sun lies in the intersection of Aquarius 1st House (the querent's well-being) and PH12 (trying situations; hidden enemies). The 1st House allows 100% accidental strength, while PH12 allows 25% accidental strength, and so Sun's overall accidental strength is  $\frac{1}{2}(100\% + 25\%) = 62.5\%$ . Therefore, circumstances are to Sun's advantage. Saturn (the house lord) disposes Sun, and so Sun is somehow dependent on it.

Caucasian Americans (the quesited) are in bad condition, but circumstances favor them to take advantage of African Americans in order to achieve their goals.

**STEP #H3:** Moon is a co-significator of the querent. As the lord of Cancer 6th House (being subject to unwholesome influences), Moon refers to African Americans as being subject to unwholesome influences. Let's assess Moon's essential dignity and accidental strength:

**Moon in Virgo 8th House:** Virgo is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. Moon lies in the intersection of Virgo 8th House (an ending that facilitates transformation) and PH7 (heavenly cooperation). The 8th House allows 25% accidental strength, while PH7 allows 100% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(25\% + 100\%) = 62.5\%$ . Therefore, circumstances are to Moon's advantage.

With the help of heavenly hands, African Americans can prevail over unwholesome influences.

**STEP #H4:** Let's give thought to other noteworthy considerations. Mercury is separating from a conjunction with Sun (the quesited). As previously found, Mercury refers to unwholesome influences that have plagued the African-American community. As the lord of Leo 7th House (someone else; opponents), Sun refers to Caucasian Americans as being an adversarial authoritative influence. The Mercury-Sun conjunction indicates that Caucasian Americans have been a source of unwholesome influences in the African-American community.

**STEP #H5:** Let's look for major aspects among the querent, the quesited, and Moon. Moon (the querent) is separating from a sinister quincunx with Sun (the quesited):

**Moon-Sun quincunx:** As previously found, Moon refers to African Americans as being subject to unwholesome influences. Moreover, as previously found, Sun refers to Caucasian Americans as being an adversarial authoritative influence. The separating quincunx aspect here indicates that there has been no common ground between Moon and Sun.

Note that the quincunx is a hard minor aspect.

**STEP #H6:** I am the astrologer, and here is my judgment. There is a power differential in which Caucasian Americans have abused African Americans. In this regard, the historical interactions between African Americans and Caucasian Americans have been mostly negative.

**COMMENTS:** On Saturday, 15 February 2025, I posed the query here to the *Yi-Jing* Oracle. The response was Hexagram 23 (Bō, 'deteriorating') changing at Lines 4 and 6, thereby showing Hexagram 16 (Yü, 'enthusiasm'). Caucasian Americans (an ethno-racial group) have been a force of deterioration that has weakened the well-being of African Americans. Nevertheless, African Americans are advised to take action that is aimed at faring well in the long run.

### 3.5 A 9th-House query: Improving my astrology skills

On Tuesday, 24 December 2024 at 09:42 am, EST, the following question formed in my mind:

**Query:** How might I best improve my skills as an astrologer?

FIGURE 3.5 presents the pertinent horary chart in terms of sidereal whole-sign houses. The *ayanāṃśa* here is 24° 11' 17" according to True Chitrā 0° Libra.

Let's use Moon to clarify the query. Firstly, Moon's primary dispositor indicates what is on the querent's mind with regard to the query. For Moon in Virgo, its primary dispositor is Mercury. As the lord of Gemini 6th House (being of service to others) and Virgo 9th House (spiritual or professional know-how), Mercury refers to my concern about using astrology to be of service to others. Secondly, Moon's house location shows an area of life that is of great interest to the querent. Moon lies in the intersection of Virgo 9th House and PH9, both houses referring to spiritual or professional know-how. This house location indicates that I am greatly interested in acquiring astrological know-how.

Now that we have clarified the query, let's use the horary-astrology rubric to get the answer.

**STEP #H1:** Firstly, let's identify the querent's significator. The querent (me) is associated with the 1st House. Because Saturn-ruled Capricorn is tied to the 1st House, Saturn is the 1st-House lord and hence the querent's significator. Secondly, let's assess the essential dignity and accidental strength of the querent's significator:

**Saturn in Aquarius 2nd House:** Aquarius is Saturn's domicile, thereby allowing 100% essential dignity. Therefore, Saturn is in good condition. Saturn lies in the intersection of

Aquarius 2nd House and PH2, both houses referring to supportive persons or things. The 2nd House and PH2 each allow 25% accidental strength, and so Saturn’s overall accidental strength is  $\frac{1}{2}(25\% + 25\%) = 25\%$ . Therefore, achieving success is a demanding effort for Saturn.

I have it within me to become a good astrologer, but I must work hard at improving my astrology skills.

**STEP #H2:** Firstly, let’s identify the quesited’s significator. The quesited pertains to astrological know-how, which is associated with the 9th House (spiritual or professional know-how). Because Mercury-ruled Virgo is tied to the 9th House, Mercury is the 9th-House lord and hence the quesited’s significator. Secondly, let’s assess the essential dignity and accidental strength of the quesited’s significator:

**Mercury in Scorpio 11th House:** Scorpio is uncongenial to Mercury, thereby allowing 50% essential dignity. Therefore, Mercury is somewhat in good condition. Mercury lies in the intersection of Scorpio 11th House (fulfilling one’s wishes) and PH10 (achieving something significant). The 11th House allows 50% accidental strength, while PH10 allows 100% accidental strength, and so Mercury’s overall accidental strength is  $\frac{1}{2}(50\% + 100\%) = 75\%$ . Therefore, circumstances are to Mercury’s advantage.

Improving my astrology skills is doable.

**STEP #H3:** Moon is a co-significator of the querent, and it is the natural representative of stages of change. Moon refers to me as being engaged in a learning process. Let’s assess Moon’s essential dignity and accidental strength:

**Moon in Virgo 9th House:** Virgo is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. Moon lies in the intersection of

Virgo 9th House and PH9, both houses referring to spiritual or professional know-how. The 9th House and PH9 each allow 50% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(50\% + 50\%) = 50\%$ . Therefore, circumstances are somewhat to Moon's advantage.

Learning astrology is doable.

**STEP #H4:** Let's give thought to other noteworthy considerations. There is nothing in this regard.

**STEP #H5:** Let's look for major aspects among the querent, the quesited, and Moon. Mercury (the quesited) is applying to a sinister square with Saturn (the querent):

**Mercury-Saturn square:** As previously found, Mercury refers to me as using astrology to be of service to others. As the lord of Aquarius 2nd House (supportive persons or things) and Capricorn 1st House (the querent), Saturn refers to me as becoming astrologically resourced (that is, having all the resources necessary to function properly). The applying square indicates a call for me to bring my astrological know-how into line with me being of service to others.

Improving my astrology skills involves diligent, unselfish efforts.

**STEP #H6:** I am the astrologer, and here is my judgment. The way is open for me to make progress in furthering my astrological know-how with an aim at helping others.

**COMMENTS:** On Wednesday, 25 December 2024, I posed the query here to the *Yi-Jing* Oracle. The response was Hexagram 54 (GUÌ MÈI, 'the junior wife') changing at Lines 2 and 4, thereby showing Hexagram 24 (FÜ, 'returning'). I am advised here to follow due process. Regarding the query, this means learning fundamental astrological knowledge and skills, listening to elder astrologers, finding out what truly matters, and complying with ethical standards of behavior.

### 3.6 Someone else's query

My friend TJB is divorced from his former wife, who has been denying him the opportunity to spend quality time with their son BB. On Friday, 31 January 2025 at 10:58 pm, CST, my friend TJB (in New Orleans, Louisiana) presented the following query to me (in Atlanta, Georgia) during a telephone conversation.

**Query:** How might I best help my son BB at this time?

FIGURE 3.6 presents the pertinent horary chart in terms of sidereal whole-sign houses. The *ayanāṃśa* here is 24° 11' 36" according to True Chitrā 0° Libra.

Let's use Moon to clarify the query. Firstly, Moon's primary dispositor indicates what is on the querent's mind with regard to the query. For Moon in Aquarius, its primary dispositor is Saturn. As the lord of Aquarius 6th House (being of service to others) and Capricorn 5th House (children), Saturn refers to TJB's concern about being a helpful parent to his son. Secondly, Moon's house location shows an area of life that is of great interest to the querent. Moon lies in the intersection

of Aquarius 6th House (being of service to others) and PH5 (children). This house location indicates that it is important to TJB that he be a helpful parent to his son.

Now that we have clarified the query, let’s use the horary-astrology rubric to get the answer.

**STEP #H1:** Firstly, let’s identify the querent’s significator. The querent (my friend TJB) is associated with the 1st House. Because Mercury-ruled Virgo is tied to the 1st House, Mercury is the 1st-House lord and hence the querent’s significator. Secondly, let’s assess the essential dignity and accidental strength of the querent’s significator:

**Mercury in Capricorn 5th House:** Capricorn is congenial to Mercury, thereby allowing 60% essential dignity. Therefore, Mercury is in good condition. Mercury lies in the intersection of Capricorn 5th House (children) and PH4 (parents). The 5th House allows 50% accidental strength, while PH4 allows 100% accidental strength, and so Mercury’s overall accidental strength is  $\frac{1}{2}(50\% + 100\%) = 75\%$ . Therefore, circumstances are to Mercury’s advantage.

TJB can be a good father, and circumstances favor him to help his son BB.

**STEP #H2:** Firstly, let’s identify the quesited’s significator. The quesited pertains to TJB’s son BB, who is associated with the 5th House (children). Because Saturn-ruled Capricorn is tied to the 5th House, Saturn is the 5th-House lord and hence the quesited’s significator. Secondly, let’s assess the essential dignity and accidental strength of the quesited’s significator:

**Saturn in Aquarius 6th House:** Aquarius is Saturn’s domicile, thereby allowing 100% essential dignity. Therefore, Saturn is in good condition. Saturn lies in the intersection of Aquarius 6th House (being of service to others and PH5 (children)). The 6th House allows 25% accidental strength, while PH5 allows 50% accidental strength, and so Saturn’s overall

accidental strength is  $\frac{1}{2}(25\% + 50\%) = 37.5\%$ . Therefore, achieving success is a demanding effort for Saturn.

BB can be a good son, but cultivating a wholesome father-son relationship is a demanding effort.

**STEP #H3:** Moon is a co-significator of the querent, and it is the natural representative of nurturers. As the lord of Cancer 11th House (fulfilling one's wishes), Moon refers to TJB as wishing to be a nurturing father. Let's assess Moon's essential dignity and accidental strength:

**Moon in Aquarius 6th House:** Aquarius is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. Moon lies in the intersection of Aquarius 6th House (being of service to others) and PH5 (children). The 6th House allows 25% accidental strength, while PH5 allows 50% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(25\% + 50\%) = 37.5\%$ . Therefore, achieving success is a demanding effort for Moon.

TJB must work at fulfilling his wish to be a nurturing father.

**STEP #H4:** Let's give thought to other noteworthy considerations. Sun is the natural representative of fathers. Mercury (the querent) is applying to a conjunction with Sun:

**Mercury-Sun conjunction:** As the lord of Gemini 10th House (achieving something significant) and Virgo 1st House (the querent), Mercury refers to TJB as working at achieving a wholesome father-son relationship. As the lord of Leo 12th House (unpleasant limitations), Sun refers to TJB as experiencing unpleasant limitations on his fatherhood. The applying conjunction here indicates an opportunity to have a wholesome father-son relationship.

Regarding fatherhood, Mercury accidentally represents TJB, while Sun naturally represents TJB.

**STEP #H5:** Let's look for major aspects among the querent, the quesited, and Moon. Moon (the querent) is separating from a conjunction with Saturn (the quesited):

**Moon-Saturn conjunction:** As previously found, Moon refers to TJB as wishing to be a nurturing father. Moreover, as previously found, Saturn refers to TJB as being a helpful parent to his son. The separating conjunction here indicates that TJB has already made some progress in achieving a wholesome father-son relationship.

TJB will eventually achieve a wholesome relationship with his son BB.

**STEP #H6:** I am the astrologer, and here is my judgment. At this time, TJB can help his son by being of service. The blogger Steve Errey stated: "A somewhat whimsical and naïve view perhaps, but giving without expectation of receiving is the truest definition of being of service."<sup>4</sup>

**COMMENTS:** On Friday, 31 January 2025, I posed the query here to the *Yi-Jing* Oracle. The response was Hexagram 42 (Yi, 'increasing') with no changing lines. TJB will experience a major improvement or increase because of his reverent commitment to God, and he is advised to do the good that God has enabled him to do.

## 4. SOME NATAL ASTROLOGY

### 4.1 Introduction

**Natal astrology** is a system of astrology that is based on the belief that a person's potential (that is, latent but unrealized abilities), opportunities, and challenges can be determined by casting an astrological chart for the person's time and place of birth. This chart is called a **natal chart**, and the person for whom it is cast is called the **native**.

Each whole-sign house of an astrological chart is represented by its **house lord**, which is the planet that rules the sign tied to the house in question. For example, if Saturn-ruled Aquarius is tied to the whole-sign 9th-House, then Saturn is the 9th-House lord. Each classical planet serves as the representative of its house(s) via its accidental role as the house lord. Moreover, each classical planet is the natural representative of some subset of persons, places, or things. We will follow astrologer Mychal A. Bryan by interpreting what a planet is doing firstly as an accidental representative and secondly as a natural representative.

As declared in Section 1.6, we will be using the sidereal zodiac and the whole-sign house system as our foundation, while overlaying Porphyry houses as nuances.

**IMPORTANT COMMENTS:** Astrologer Isabel M. Hickey said that: "Fate is earmarked in tendencies, not in facts. All anyone can see in a birth chart are tendencies that will become facts if one does not do something to alter them." In the divinatory corpus of the *Ifá* spiritual system, it says in chapter *Ogbè Ògúndá* that: "It is character alone that speaks. Personal destiny is never bad in *Ilé-Iḡè* (a *Yorùbá* town that symbolizes earthly life). It is character alone that speaks." No one is born into the world with a bad destiny; it is one's character that makes or breaks them.

### 4.2 King's natal chart

On Tuesday, 15 January 1929, Michael King Jr. was born to Michael King Sr. and his wife Alberta Williams King at the family home (501 Auburn Avenue) in Atlanta, Georgia. According to his mother Alberta, the junior King was born at high noon. After returning from a trip to Germany in August 1934, the senior King changed his own name to Martin Luther King Sr. and his son's name to Martin Luther King Jr.

The late Dr. Martin Luther King Jr. was a civil-rights leader who campaigned against racial injustice in America. King famously said: "Injustice anywhere is a threat to justice everywhere." Moreover, he famously said: "The arc of the moral universe is long, but it bends toward justice."

FIGURE 4.2 presents the natal chart of Martin Luther King Jr. in terms of sidereal whole-sign houses. The *ayanāṃśa* here is  $22^{\circ} 51' 05''$  according to True Chitrā  $0^{\circ}$  Libra. Note that Atlanta

was in the Central Time Zone until legislation switched it to the Eastern Time Zone on Friday, 21 March 1941.

In this section, we will take a basic look at King’s natal chart by: [1] examining the 1st House; [2] examining the Lots of Fortune, Spirit, and Retribution; and [3] looking for interesting astrological configurations.

## EXAMINING THE 1ST HOUSE

The 1st House takes after PC1 (the Ascendant), which represents bodily life (and by extension, bodily health). The 1st House refers to the persona, which is the vehicle of personality (that is, characteristic way of thinking, feeling, and behaving) through which one navigates earthly life. The 1st House refers to one’s well-being (that is, state of being happy, healthy, and prosperous).

Examining the natal 1st House answers the question “Who is the native?” in astrological terms. In order to examine the 1st House, it is useful to consider: [1] the Ascendant and major aspects to it, [2] planets in the 1st House, and [3] the Ascendant ruler and its major aspects.

Firstly, let’s consider the Ascendant and major aspects to it. In King’s natal chart, PC1 (the Ascendant) is at Aries 20° 57' 33". The rising sign (that is, the sign of the Ascendant) refers to the native’s central personality traits:

**Aries Ascendant:** The sign Aries expresses Mars in a masculine way. As a fire sign, Aries is desirous, energetic, and forthright. As a cardinal sign, Aries initiates action and creates change. Like a combative ram, Aries likes challenges and has an abundant amount of physical energy.

Aries is courageous and pioneering – he is always ready to take risks. In his eagerness to get things done, he is inclined to act first and think later. Like a charging ram, he rushes headlong into situations without considering the consequences. At his best, masculine Aries has the courage to jump into action in order to enthusiastically pursue worthy goals.

Let's move on!

Planets that make major aspects to PC1 indicate factors that add to the native's central personality traits. Moon is making a sinister sextile to PC1:

**Moon-PC1 sextile:** Accidentally speaking, Moon is the lord of Cancer 4th House (traditional know-how). Intrinsically speaking, Moon is the natural representative of nurturers. Regarding house location, Moon lies in the intersection of Aquarius 11th House and PH11, both houses referring to comrades and shared interests. At his best, masculine Aquarius is unselfish and makes improvements for the common good. In light of the foregoing, Moon refers to King as applying traditional know-how to further the common good. The sextile aspect here refers to Moon as being helpful to PC1 (the native).

Aquarius is uncongenial to Moon, thereby allowing 50% essential dignity. Therefore, Moon is somewhat in good condition. The 11th House and PH11 each allow 50% accidental strength, and so Moon's overall accidental strength is  $\frac{1}{2}(50\% + 50\%) = 50\%$ . Therefore, circumstances are somewhat to Moon's advantage.

Mercury is making a sinister square to PC1:

**Mercury-PC1 square:** Accidentally speaking, Mercury is the lord of Gemini 3rd House (community) and Virgo 6th House (being of service to others). Intrinsically speaking, Mercury is the natural representative of clever action, speech, and expertise. Regarding house location, Mercury lies in the intersection of Capricorn 10th House and PH10, both houses referring to achieving something significant. At her best, feminine Capricorn is diligent – she gives steady, meticulous attention to ongoing tasks. In light of the foregoing, Mercury refers to King as achieving something significant by being a clever, diligent advocate for his community. The square aspect here indicates a call for King to bring his Aries boldness and enthusiasm into line with Mercury's cleverness and verbal facility.

Capricorn is congenial to Mercury, thereby allowing 60% essential dignity. Therefore, Mercury is in good condition. The 10th House and PH10 each allow 100% accidental strength, and so Mercury's overall accidental strength is  $\frac{1}{2}(100\% + 100\%) = 100\%$ . Therefore, circumstances are to Mercury's advantage.

Venus is making a sinister sextile to PC1:

**Venus-PC1 sextile:** Accidentally speaking, Venus is the lord of Libra 7th House (partnerships) and Taurus 2nd House (supportive persons or things). Intrinsically speaking, Venus is the natural representative of friendly action and intimate relationships. Regarding house location, Venus lies in the intersection of Aquarius 11th House and PH11, both houses referring to comrades and shared interests. At his best, masculine Aquarius is unselfish and makes improvements for the common good. In light of the foregoing, Venus refers to King as working together with others in order to further the common good. The sextile aspect here refers to Venus as being helpful to PC1 (the native).

Aquarius is congenial to Venus, thereby allowing 60% essential dignity. Therefore, Venus is in good condition. The 11th House and PH11 each allow 50% accidental strength, and so Venus's overall accidental strength is  $\frac{1}{2}(50\% + 50\%) = 50\%$ . Therefore, circumstances are somewhat to Venus's advantage.

Let's move on!

Secondly, let's consider planets in the 1st House. Such planets indicate factors that add to the native's central personality traits. Jupiter is in the 1st House:

**Jupiter in Aries 1st House:** Accidentally speaking, Jupiter is the lord of Pisces 12th House (trying situations) and Sagittarius 9th House (spiritual or professional know-how). Intrinsically speaking, Jupiter is the natural representative of noble-minded action, high social position, and religion/spirituality. Regarding house location, Jupiter lies in the intersection of Aries 1st House (the native's well-being) and PH12 (trying situations). At his best, masculine Aries has the courage to jump into action in order to enthusiastically pursue worthy goals. In light of the foregoing, Jupiter refers to King as achieving a high position by boldly dealing with trying situations through spiritual guidance.

Aries is congenial to Jupiter, thereby allowing 60% essential dignity. Therefore, Jupiter is in good condition. The 1st House allows 100% accidental strength, while PH12 allows 25% accidental strength, and so Jupiter's overall accidental strength is  $\frac{1}{2}(100\% + 25\%) = 62.5\%$ . Therefore, circumstances are to Jupiter's advantage.

In his book *Stride Toward Freedom*, King wrote that his reformist approach of nonviolent resistance was a courageous confrontation of evil by the power of love.

Thirdly, let's consider the Ascendant ruler and its major aspects. The Ascendant ruler represents the native, and its house location indicates where the native gives great attention and great effort. Mars rules Aries (the rising sign), and so it is the Ascendant ruler. For Mars, we find the following:

**Mars in Taurus 2nd House:** Accidentally speaking, Mars is the lord of Aries 1st House (the native's well-being) and Scorpio 8th House (an ending that facilitates transformation). Intrinsically speaking, Mars is the natural representative of energetic assertive action. Regarding house location, Mars lies in the intersection of Taurus 2nd House and PH2, both houses referring to supportive persons or things. At her best, feminine Taurus is doggedly determined to make tangible progress in achieving a better quality of life. In light of the foregoing, Mars refers to King as enthusiastically engaging in self-betterment.

Taurus is uncongenial to Mars, thereby allowing 50% essential dignity. Therefore, Mars is somewhat in good condition. The 2nd House and PH2 each allow 25% accidental strength, and so Mars's overall accidental strength is  $\frac{1}{2}(25\% + 25\%) = 25\%$ . Therefore, achieving success is a demanding effort for Mars.

Let's move on!

Planets that make major aspects with the Ascendant ruler indicate factors that affect the Ascendant ruler for good or bad. Moon is applying to a sinister square with Mars:

**Moon-Mars square:** As previously found, Moon refers to King as applying traditional know-how to further the common good. Moreover, as previously found, Mars refers to King as enthusiastically engaging in self-betterment. The square aspect here indicates a call for King to bring his efforts of self-betterment into line with his efforts for the common good.

Mars is separating from an opposition with Saturn:

**Mars-Saturn opposition:** As previously found, Mars refers to King as enthusiastically engaging in self-betterment. Accidentally speaking, Saturn is the lord of Aquarius 11th House (comrades and shared interests) and Capricorn 10th House (achieving something significant). Intrinsically speaking, Saturn is the natural representative of sober-minded action. Regarding house location, Saturn lies in the intersection of Sagittarius 9th House (spiritual or professional know-how) and PH8 (an ending that facilitates transformation). At his best, masculine Sagittarius is not afraid to go beyond his comfort zone and to take risks in order to achieve worthy goals. In light of the foregoing, Saturn refers to King as achieving something significant by taking transformative, spiritual action to further the common good. The opposition aspect here indicates a call for King to harmonize his efforts of self-betterment with his efforts for the common good.

Sagittarius is uncongenial to Saturn, thereby allowing 50% essential dignity. Therefore, Saturn is somewhat in good condition. The 9th House allows 50% accidental strength, while PH8 allows 25% accidental strength, and so Saturn's overall accidental strength is  $\frac{1}{2}(50\% + 25\%) = 37.5\%$ . Therefore, achieving success is a demanding effort for Saturn.

King famously spoke of the 'beloved community', which he viewed as an achievable society in which justice, equal opportunity, and love for all human beings prevail.

## EXAMINING THE LOTS OF FORTUNE, SPIRIT, AND RETRIBUTION

In King's natal chart, the Ascendant is at Aries  $20^{\circ} 57' 33''$ , Sun is at Capricorn  $02^{\circ} 16' 59''$ , Moon is at Aquarius  $26^{\circ} 44' 06''$ , and Saturn is at Sagittarius  $02^{\circ} 30' 02''$ . For the Lot of Fortune, we get

$$\begin{aligned} LFo &= Asc + Moon - Sun = 20^{\circ} 57' 33'' + 326^{\circ} 44' 06'' - 272^{\circ} 16' 59'' \\ &= 75^{\circ} 24' 40'' = 60^{\circ} + 15^{\circ} 24' 40'', \end{aligned}$$

which is Gemini  $15^{\circ} 24' 40''$ . For the Lot of Spirit, we get

$$\begin{aligned} LSp &= Asc + Sun - Moon = 20^{\circ} 57' 33'' + 272^{\circ} 16' 59'' - 326^{\circ} 44' 06'' \\ &= -33^{\circ} 29' 34'' \equiv -33^{\circ} 29' 34'' + 360^{\circ} = 326^{\circ} 30' 26'' = 300^{\circ} + 26^{\circ} 30' 26'', \end{aligned}$$

which is Aquarius  $26^{\circ} 30' 26''$ . For the Lot of Retribution, we get

$$\begin{aligned} LRe &= Asc + Saturn - LFo = 20^{\circ} 57' 33'' + 242^{\circ} 30' 02'' - 75^{\circ} 24' 40'' \\ &= 188^{\circ} 02' 55'' = 180^{\circ} + 08^{\circ} 02' 55'', \end{aligned}$$

which is Libra  $08^{\circ} 02' 55''$ .

The Lot of Fortune indicates how and where one can attract good luck to support their efforts. Regarding house location, King's natal Lot of Fortune lies in the intersection of Gemini 3rd House and PH3, both houses referring to community. At his best, masculine Gemini seeks to learn and communicate in order to further wholesome intellectual development. Gemini is ruled by Mercury, and so Mercury is the Lot's dispositor. As previously found, Mercury refers to King as achieving something significant by being a clever, diligent advocate for his community. In light of the foregoing, King can attract good luck by being a clever, diligent advocate of that which furthers the wholesome intellectual development of his community.

The Lot of Spirit indicates how and where one can wholesomely develop their life potential. Regarding house location, King's natal Lot of Spirit lies in the intersection of Aquarius 11th House and PH11, both houses referring to comrades and shared interests. At his best, masculine Aquarius is unselfish and makes improvements for the common good. Aquarius is ruled by Saturn, and so Saturn is the Lot's dispositor. As previously found, Saturn refers to King as achieving something significant by taking transformative, spiritual action to further the common good. In light of the foregoing, King can wholesomely develop his life potential by engaging in fellowship with others who seek to further the common good.

The Lot of Retribution indicates how and where one can meet their downfall. Regarding house location, King's natal Lot of Retribution lies in the intersection of Libra 7th House (romantic partners) and PH6 (being subject to unwholesome influences). Masculine Libra seeks to be surrounded by beauty and harmony. Libra is ruled by Venus, and so Venus is the Lot's dispositor. Venus is the natural representative of friendly action, intimate relationships, and personal charm. In light of the foregoing, the Lot of Retribution refers to King's extramarital affairs. The FBI (Federal Bureau of Investigation) used recorded material of King's romantic affairs in an orchestrated effort to ruin his reputation.

## LOOKING FOR INTERESTING ASTROLOGICAL CONFIGURATIONS

Let's now look for interesting astrological configurations in King's natal chart. In this regard, Sun is making a conjunction to PC10 (the Midheaven):

**Sun-PC10 conjunction:** Accidentally speaking, Sun is the lord of Leo 5th House (personal interests). Intrinsicly speaking, Sun is the natural representative of leaders and social recognition. Regarding house location, Sun lies in the intersection of Capricorn 10th House (achieving something significant; gaining prestige; head persons) and PH9 (spiritual or professional know-how). At her best, feminine Capricorn is diligent – she gives steady, meticulous attention to ongoing tasks. In light of the foregoing, Sun refers to King as achieving recognition through diligent leadership efforts involving spiritual know-how. The conjunction here refers to Sun as being helpful to PC10 (achieving something significant).

Capricorn is uncongenial to Sun, thereby allowing 50% essential dignity. Therefore, Sun is somewhat in good condition. The 10th House allows 100% accidental strength. PH9 usually allows 50% accidental strength, but Sun has its joy there, and so  $\frac{1}{2}(50\% + 100\%) = 75\%$  is Sun's accidental strength in PH9. Consequently, Sun's overall accidental strength is  $\frac{1}{2}(100\% + 75\%) = 87.5\%$ . Therefore, circumstances are to Sun's advantage.

As a co-founder of SCLC (Southern Christian Leadership Conference), King used the power of black churches to conduct nonviolent protests aimed at civil-rights reform.

### 4.3 The Profected Ascendant

The Latin-derived noun ‘**profection**’ means ‘a movement forward’. The **Profected Ascendant** (PAsc) is the result of moving the natal Ascendant forward at a rate of 30° per year of life. More specifically, for the native at *A* sidereal years of age, we add

$$\text{profection addition term} = (30 \times A) \text{ deg}$$

to the natal Ascendant in order to get the pertinent PAsc.

In order to examine the native’s life at a given time, we will consider: [1] PAsc and major aspects to it, [2] planets in PAsc’s house location, and [3] the PAsc ruler and its major aspects.

On Wednesday, 28 August 1963, Martin Luther King Jr. delivered his famous “I Have A Dream” speech during the March on Washington for Jobs and Freedom. Let’s use the Profected Ascendant together with hindsight in order to see how King’s DC speech shows us astrologically.

By the date of his speech, King had lived through 8 leap days (namely, those of 1932, 1936, 1940, 1944, 1948, 1952, 1956, and 1960). It follows that on the date of his speech, King’s sidereal age was about

$$\frac{[(8 \times 366) + (26 \times 365) + 16 + 28 + 31 + 30 + 31 + 30 + 31 + 28] \text{ days}}{365.256363 \text{ days/yr}} \\ \approx 34.61405 \text{ yrs .}$$

For  $A \approx 34.61405$ , we get

$$\text{profection addition term} = (30 \times A) \text{ deg} \approx 1038.42150 \text{ deg} \\ \approx 1038 \text{ deg} + 25 \text{ min} + 17 \text{ sec} = 1038^\circ 25' 17'' .$$

The natal Ascendant is at Aries  $20^\circ 57' 33''$ , and so its ecliptic longitude is  $20^\circ 57' 33''$ . We find that PAsc's ecliptic longitude is

$$20^\circ 57' 33'' + 1038^\circ 25' 17'' = 1059^\circ 22' 50'' = 2 \times 360^\circ + 339^\circ 22' 50'' \\ \equiv 339^\circ 22' 50'' = 330^\circ + 09^\circ 22' 50'' ,$$

which is Pisces  $09^\circ 22' 50''$ . FIGURE 4.3 shows PAsc in King's natal chart.

Firstly, let's consider PAsc and major aspects to it. PAsc's house location describes the native's situation at the time of interest. The core agenda of the March on Washington for Jobs and Freedom was to advocate for civil rights and economic equality for African Americans. On the date of King's speech, PAsc lies in the intersection of Pisces 12th House (trying situations) and PH11 (comrades and shared interests). At her best, feminine Pisces is resilient and shows kindly concern for others.

Planets that make major aspects to PAsc indicate factors that further describe the native's situation at the time of interest. Saturn is making a sinister square to PAsc:

**Saturn-PAsc square:** As previously found in Section 4.2, Saturn refers to King as achieving something significant by taking transformative, spiritual action to further the common good. The square aspect here indicates a call for King to bring the agenda of the occasion (the March on Washington for Jobs and Freedom) into line with his transformative vision.

The March involved a number of civil-rights organizations that each had its own agenda and that competed for funding and press coverage.

Secondly, let's consider planets in PAsc's house location. Such planets further describe the native's situation at the time of interest. There is nothing in this regard.

Thirdly, let's consider the PAsc ruler and its major aspects. The PAsc ruler represents the native at the time of interest, and its house location indicates where the native gives great attention and great effort. Pisces is ruled by Jupiter, and so Jupiter is the PAsc ruler. As previously found in Section 4.2, Jupiter refers to King as achieving a high position by boldly dealing with trying situations through spiritual guidance. Having 60% essential dignity, Jupiter is in good condition. Having 62.5% accidental strength, circumstances are to Jupiter's advantage.

Sun is applying to a sinister square with Jupiter:

**Sun-Jupiter square:** As previously found in Section 4.2, Sun refers to King as achieving recognition through diligent leadership efforts involving spiritual know-how. Moreover, as

previously found in Section 4.2, Jupiter refers to King as achieving a high position by boldly dealing with trying situations through spiritual guidance. The square aspect here indicates a call for King to bring trying situations into line with spiritual standards.

Jupiter is separating from a dexter trine with Saturn:

**Jupiter-Saturn trine:** As previously found in Section 4.2, Jupiter refers to King as achieving a high position by boldly dealing with trying situations through spiritual guidance. As previously found in Section 4.2, Saturn refers to King as achieving something significant by taking transformative, spiritual action to further the common good. The trine aspect here refers to Jupiter and Saturn as being mutually helpful.

In his famous “I Have A Dream” speech, King addressed the issue of racial inequality in America, and he argued that racial justice is in accord with God’s will.

## 4.4 King’s 1968 solar-return chart

The native’s **solar return** (SR) is Sun’s annual return to its natal position. This return occurs on or close to the native’s birthday. A solar-return year spans the time interval from one solar return to the next one. In astrology, the noun ‘**transit**’ refers to the ongoing movement of a planet across the sky. In working with transits, we look at current planetary positions. A **solar-return chart** is a transit chart that is cast for the time when a solar return occurs, and we take it to represent the entire associated solar-return year.

In order to examine a solar-return chart, we will place the natal and solar-return charts side-by-side and then apply the following **solar-return rubric**:

- **STEP #S1:** The SR Ascendant (which we will call ‘SR1’) represents the native during the pertinent solar-return year. Place SR1 in the natal chart. The natal house location of SR1 indicates prominent matters in the native’s life during the pertinent solar-return year. Look for major aspects to SR1 within the natal chart.
- **STEP #S2:** Look for major aspects to SR1 within the SR chart.
- **STEP #S3:** Identify the SR1 ruler and assess it within the natal chart. Look for major aspects involving the SR1 ruler within the natal chart.
- **STEP #S4:** Assess the SR1 ruler within the SR chart. Look for major aspects involving the SR1 ruler within the SR chart.
- **STEP #S5:** Continue going back-and-forth between the natal and solar-return charts until they together yield coherent messages for the pertinent solar-return year.

This rubric (that is, set of procedural rules) is presented by astrologer Mychal A. Bryan in his book *Horary Astrology & the Natal Promise* and in some of his video presentations.

\*\*\*

FIGURE 4.4a presents the natal chart of Martin Luther King Jr. in terms of sidereal whole-sign houses. The *ayanāṃśa* here is 22° 51' 05" according to True Chitrā 0° Libra. Note that Atlanta

was in the Central Time Zone until legislation switched it to the Eastern Time Zone on Friday, 21 March 1941.

On Monday, 15 January 1968, Martin Luther King Jr. reached age 39. Let’s cast the solar-return chart for King at age 39. In King’s natal chart, Sun’s tropical ecliptic longitude is 295° 08’ 04”. The *ayanāṃśa* on King’s date of birth is 22° 51’ 05” according to True Chitrā 0° Libra. On

subtracting this *ayanāṃśa* from Sun's tropical ecliptic longitude, we get  $272^{\circ} 16' 59''$ , which is Sun's sidereal ecliptic longitude in the natal chart. Around King's 39th birthday, Sun's sidereal ecliptic longitude is  $272^{\circ} 16' 59''$  on Tuesday, 16 January 1968 at 01:00:30 pm, EST. FIGURE 4.4a presents King's 1968 SR chart in terms of sidereal whole-sign houses. The *ayanāṃśa* on the SR date is  $23^{\circ} 23' 44''$  according to True Chitrā  $0^{\circ}$  Libra.

About three months after his 39th birthday, King was assassinated on Thursday, 04 April 1968 in Memphis, Tennessee. It makes sense that King's passing is the foremost event of his life at age 39. Let's apply the solar-return rubric together with hindsight in order to see how King's passing shows up astrologically.

**STEP #S1:** Firstly, let's place SR1 in the natal chart (FIGURE 4.4a). SR1 is at Aries  $21^{\circ} 16' 46''$ . Within the natal chart, SR1 lies in the intersection of Aries 1st House and PH1, both houses referring to the native's well-being. Therefore, 1st-House matters are prominent in King's life at age 39.

Secondly, let's look for major aspects to SR1 within the natal chart. SR1 is within  $01^{\circ}$  of the natal Ascendant, and so both Ascendants are involved in the same aspects. To both Ascendants, Moon makes a sinister sextile, Mercury makes a sinister square, and Venus makes a sinister sextile. These aspects have been discussed in Section 4.2.

**STEP #S2:** Let's look for major aspects to SR1 within the SR chart (FIGURE 4.4b). Moon makes a dexter square to SR1:

**[SR] Moon-SR1 square:** Accidentally speaking, Moon is the lord of Cancer 4th House (being gravebound). Intrinsically speaking, Moon is the natural representative of stages of change. Regarding house location, Moon lies in the intersection of Cancer 4th House and PH4, both houses referring to being gravebound. At her best, feminine Cancer safeguards those who are near and dear. In light of the foregoing, Moon refers to King as being commemorated after bodily death. The square aspect here refers to Moon as bringing SR1 (the native) into line with its agenda of bodily death.

Let's move on!

**STEP #S3:** Firstly, let's identify the SR1 ruler and assess it within the natal chart (FIGURE 4.4a). Mars rules Aries (the SR rising sign), and so it is the SR1 ruler. For natal Mars, we find the following:

**[Natal] Mars in Taurus 2nd House:** As previously found in Section 4.2, Mars refers to King as enthusiastically engaging in self-betterment. With regard to King's passing, let's look further into Mars. Accidentally speaking, Mars is the lord of Aries 1st House (the native) and Scorpio 8th House (bodily death). Intrinsically speaking, Mars is the natural representative of hostile action and bodily injury. On putting it all together, Mars refers to King as enthusiastically engaging in self-betterment, despite the threat of bodily death or bodily harm.

King faced constant threats of violence that came primarily from white supremacy groups and from a covert surveillance and harassment campaign that was orchestrated by the FBI (Federal Bureau of Investigation).

Secondly, let's look for major aspects involving the SR1 ruler within the natal chart. Moon is applying to a sinister square with Mars:

**[Natal] Moon-Mars square:** As previously found in Section 4.2, the Moon-Mars square indicates a call for King to bring his efforts of self-betterment into line with his efforts for the common good. King answers this call despite the threat of bodily death or bodily harm.

Mars is separating from an opposition with Saturn:

**[Natal] Mars-Saturn opposition:** As previously found in Section 4.2, the Mars-Saturn opposition indicates a call for King to harmonize his efforts of self-betterment with his efforts for the common good. King answers this call despite the threat of bodily death or bodily harm.

King famously said: "The time is always right to do what is right."

**STEP #S4:** Firstly, let's assess the SR1 ruler within the SR chart (FIGURE 4.4b). For SR Mars, we find the following:

**[SR] Mars in Aquarius 11th House:** Accidentally speaking, Mars is the lord of Aries 1st House (the native) and Scorpio 8th House (an ending that facilitates transformation). Intrinsicly speaking, Mars is the natural representative of energetic assertive action. Regarding house location, Mars lies in the intersection of Aquarius 11th House and PH11, both houses referring to comrades and shared interests. At his best, masculine Aquarius is unselfish and makes improvements for the common good. In light of the foregoing, Mars refers to King as enthusiastically working to further the common good.

With regard to King's passing, let's look further into Mars. Accidentally speaking, Mars is the lord of Aries 1st House (the native) and Scorpio 8th House (bodily death). Intrinsicly speaking, Mars is the natural representative of hostile action and bodily injury. On putting it all together, Mars refers to King as enthusiastically working to further the common good, despite the threat of bodily death or bodily harm.

In a speech on the night before his assassination, King said: "Like anybody, I would like to live a long life. Longevity has its place. But I'm not concerned about that now. I just want to do God's will."

Secondly, let's look for major aspects involving the SR1 ruler within the SR chart. Mars is separating from an opposition with Jupiter:

**[SR] Mars-Jupiter opposition:** As previously found, Mars refers to King as enthusiastically working to further the common good, despite the threat of bodily death or bodily harm. Accidentally speaking, Jupiter is the lord of Pisces 12th House (hidden enemies) and Sagittarius 9th House (hidden enemies achieving success). Note that we are viewing the 9th House here as the derived 10th House (achieving something significant) with respect to the 12th House (hidden enemies). Intrinsicly speaking, Jupiter is the natural representative of high social position. Regarding house location, Jupiter lies in the intersection of Leo 5th House and PH5, both houses referring to personal interests. Masculine Leo likes things to be done his way. In light of the foregoing, Jupiter refers to people in high places whose personal interests are contrary to those of King. The opposition aspect here refers to Jupiter's powerful resistance to King because of his Mars courageous altruism.

The FBI viewed King as being dangerous because it believed that he could become a messiah who could unify black nationalists. In the last few months of King's life, the FBI intensified its efforts to discredit King and to 'neutralize' SCLC (King's organization).

**STEP #S5:** Let's continue going back-and-forth between the natal and solar-return charts until they together yield coherent messages for the pertinent solar-return year. Firstly, let's consider the major aspects to SR1. The natal Moon-SR1 sextile Moon refers to King as applying traditional know-how to further the common good. The natal Mercury-SR1 square refers to King as bringing his boldness and enthusiasm into line with his clever, diligent, communal advocacy. The natal Venus-SR1 sextile refers to King as working together with others to further the common good. The SR Moon-SR1 square refers to King as being commemorated after bodily death. The coherent message here is that King's devoted social advocacy leads to him being commemorated after his bodily death.

Secondly, let's consider the major aspects involving the SR1 ruler (Mars). The natal Moon-Mars square and the natal Mars-Saturn opposition both refer to King as enduring the threat of bodily death or bodily harm as he furthers the common good. The SR Mars-Jupiter opposition refers to powerful resistance to King because of his courageous altruism. The coherent message here is that King gets assassinated because powerful enemies oppose his courageous altruistic efforts to further the common good.

**IMPORTANT COMMENTS:** There is disagreement among astrologers about the location for which a return chart should be cast. Some believe that the chart should be cast for the native's location at the time of the return. Others believe that the return chart should be cast for the native's birthplace, regardless of the native's location at the time of the return. We side with the latter group.

## 4.5 King's passing: natal primary directions

Earth's axial rotation gives rise to primary motion. From the point of view of an earthbound observer, primary motion is perceived as Earth remaining at rest while the surrounding celestial sphere and everything on it (including the zodiacal belt) rotate about Earth's line of poles. The **method of primary directions** is a technique that uses primary motion to predict events. According to this technique, each longitudinal degree of Earth's axial rotation corresponds to approximately one completed year of the native's life. It takes about 4 minutes for Earth to longitudinally rotate by  $01^\circ$ , and so the native's life at  $A$  sidereal years of age is revealed by what is happening astrologically when they are about  $(4 \times A)$  minutes old. For example, the native's life at age 90 is revealed by an astrological chart that is cast for when the native is about 360 minutes old.

If we take age 90 to be the human life span, then we can examine the native's entire life based on what is happening astrologically during the first 360 minutes (or 6 hours) after his birth. From TABLE 2.3, we see that each planet (apart from Moon) does not move very much along the zodiac during a 6-hour time period, and so we may view primary motion as causing the zodiacal belt (with the planets attached to it) to rotate backward through fixed houses of the local sky. During the 6-

hour time period after birth, primary motion directs the planets into major aspects with the angles (the Ascendant, the Descendant, the Midheaven, and the Imum Coeli).

In Appendix A, we deal with primary directions in a mathematically elaborate way. But in this section, we will be dealing with primary directions in the fast and easy way that is presented by astrologer Anthony Louis in his blog post *Fast and Easy Primary Directions* (20 July 2019).

The **Naibod time-key** is the notion that each 00° 59' 08.19" of Earth's axial rotation corresponds to one sidereal year of age. It follows that every addition of about 3.93167189 minutes to the birth time symbolically advances the natal chart by one sidereal year of age. The notion of natal primary directions gives rise to the following technique:

- **TECHNIQUE #PD1:** In order to examine the native's life around *A* sidereal years of age, cast symbolic charts for about  $(3.93167189 \times A)$  minutes before and after the birth time. In these symbolic charts, look for major planet-to-angle aspects, taking the margin of inexactness to be about 01°. These major aspects are primary directions that each predict an event to occur in the native's life around *A* sidereal years of age.

Technique #PD1 helps us to look for prominent events at any age of the native's life. The primary directions that are shown in the pre-birth symbolic chart are said to be *neo-converse*. The primary directions that are shown in the post-birth symbolic chart are said to be *direct*.

On Thursday, 04 April 1968, Martin Luther King Jr. was assassinated. Let's apply Technique #PD1 together with hindsight in order to see how King's passing shows up within the context of natal primary directions. By the date of his passing, King had lived through 10 leap days (namely, those of 1932, 1936, 1940, 1944, 1948, 1952, 1956, 1960, 1964, and 1968). It follows that on the date of his passing, King's sidereal age was about

$$\frac{[(9 \times 366) + (30 \times 365) + 16 + 29 + 31 + 4] \text{ days}}{365.256363 \text{ days/yr}} \approx 39.21629 \text{ yrs.}$$

On applying Technique #PD1 for  $A \approx 39.21629$ , we get

$$(3.93167189 \times A) \text{ min} \approx 154.18559 \text{ min} \approx 2 \text{ hr} + 34 \text{ min} + 11 \text{ sec}$$

as the chart-change term with respect to the natal chart (FIGURE 4.5a).

For the pre-birth symbolic chart (FIGURE 4.5b), we subtract the chart-change term (2 hours, 34 minutes, and 11 seconds) from King’s birth time of 12:00 pm, CST, thereby getting 09:25:49 am, CST. In this symbolic chart, we are looking for neo-converse primary directions that are associated with King’s life around age 39. These are major planet-to-angle aspects having a margin of inexactness of about  $01^\circ$ . In this regard, we find a Moon-PC1 conjunction and a Mars-PC4 conjunction.

In the pre-birth symbolic chart, the Mars-PC4 conjunction is a neo-converse primary direction that may refer to King’s passing. As previously found in Section 4.4, Mars refers to King as enthusiastically engaging in self-betterment, despite the threat of bodily death or bodily harm. PC4 (the Imum Coeli) refers to being gravebound. The conjunction aspect here refers to Mars as being helpful to PC4.

By trial and error, we find that the Mars-PC4 conjunction becomes exact at about 09:23:58 am, CST on Tuesday, 15 January 1929 (King’s birth date). From 09:23:58 am, CST to 12:00 pm, CST (King’s birth time), the time difference is

$$\text{elapsed time} = 2 \text{ hr} + 36 \text{ min} + 2 \text{ sec} \approx 156.03333 \text{ min} .$$

On making use of the Naibod time-key, this time difference corresponds to an age difference of

$$\begin{aligned} \text{elapsed age} &\approx \frac{1 \text{ yr of age}}{3.93167189 \text{ min}} \times 156.03333 \text{ min} \approx 39.68625 \text{ yrs} \\ &= 39 \text{ yrs} + \left( 0.68625 \text{ yr} \times \frac{365.256363 \text{ days}}{1 \text{ yr}} \right) \approx 39 \text{ yrs} + 250.65718 \text{ days} , \end{aligned}$$

and so the neo-converse Mars-PC4 conjunction predicts an event to occur about 251 days after Monday, 15 January 1968 (King’s 39th birthday), which is on Sunday, 22 September 1968.

In Section B1 of Appendix B, we apply the primary-direction formula to the converse Mars-PC4 conjunction. On taking it to be traditionally converse, we get a prediction date in 1971. On taking it to be neo-converse, we get a prediction date of Monday, 23 December 1968.

For the post-birth symbolic chart (FIGURE 4.5c), we add the chart-change term (2 hours, 34 minutes, and 11 seconds) to King’s birth time of 12:00 pm, CST, thereby getting 02:34:11 pm, CST. In this symbolic chart, we are looking for direct primary directions that are associated with King’s life around age 39. These are major planet-to-angle aspects having a margin of inexactness of about 01°. In this regard, we find a Saturn-PC7 conjunction.

In the post-birth symbolic chart, the Saturn-PC7 conjunction is a direct primary direction that may refer to King’s passing. As previously found in Section 4.2, natal Saturn refers to King as achieving something significant by taking transformative, spiritual action to further the common good. PC7 (the Descendant) refers to heavenly cooperation. The conjunction aspect here refers to Saturn as being helpful to PC7. But how does this conjunction refer to King’s passing?

Let's look at Saturn within the post-birth symbolic chart. Accidentally speaking, Saturn is the lord of post-birth Aquarius 9th House (supportive factors to bodily death) and post-birth Capricorn 8th House (bodily death). Note that we are viewing the 9th House here as the derived 2nd House (supportive persons or things) with respect to the 8th House (bodily death). Intrinsicly speaking, Saturn is the natural representative of death. Regarding house location, Saturn lies in the intersection of post-birth Sagittarius 7th House (opponents; bodily death or bodily harm) and post-birth PH6 (being subject to unwholesome influences). In light of the foregoing, Saturn refers to bodily death as a result of unwholesome opponents. On putting it all together, Saturn refers to King's bodily death at the hands of unwholesome people who oppose his transformative, spiritual efforts. PC7 refers to bodily death or bodily harm. The conjunction aspect here refers to Saturn as being helpful to PC7.

By trial and error, we find that the Saturn-PC7 conjunction becomes exact at about 02:30:59 pm, CST on Tuesday, 15 January 1929 (King's birth date). From 12:00 pm, CST (King's birth time) to 02:30:59 pm, CST, the time difference is

$$\text{elapsed time} = 2 \text{ hr} + 30 \text{ min} + 59 \text{ sec} = 150.98333 \text{ min} .$$

On making use of the Naibod time-key, this time difference corresponds to an age difference of

$$\begin{aligned} \text{elapsed age} &\approx \frac{1 \text{ yr of age}}{3.93167189 \text{ min}} \times 150.98333 \text{ min} \approx 38.40181 \text{ yrs} \\ &= 38 \text{ yrs} + \left( 0.40181 \text{ yr} \times \frac{365.256363 \text{ days}}{1 \text{ yr}} \right) \approx 38 \text{ yrs} + 146.76366 \text{ days} , \end{aligned}$$

and so the direct Saturn-PC7 conjunction predicts an event to occur about 147 days after Sunday, 15 January 1967 (King's 38th birthday), which is on Sunday, 11 June 1967.

In Section B2 of Appendix B, we apply the primary-direction formula to the direct Saturn-PC7 conjunction, thereby getting a prediction date of Thursday, 13 June 1968.

## 4.6 King's passing: SR primary directions

Let's adapt Technique #PD1 (of Section 4.5) for use with solar-return charts. The **SR time-key** is the notion that each degree of Earth's axial rotation corresponds to each degree of Earth's orbital motion. It follows that every addition of about 3.93167189 minutes to the SR time symbolically advances the SR chart by one mean solar day of age. See Section A5 of Appendix A for pertinent details. Here is our technique for SR primary directions:

- **TECHNIQUE #PD2:** In order to examine the native's life around  $D$  mean solar days after the SR date, cast symbolic charts for about  $(3.93167189 \times D)$  minutes before and after the SR time. In these symbolic charts, look for major planet-to-angle aspects, taking the margin of inexactness to be about  $01^\circ$ . These major aspects are primary directions that each predict an event to occur in the native's life around  $D$  days after the SR date.

The primary directions that are shown in the pre-SR symbolic chart are said to be *neo-converse*. The primary directions that are shown in the post-SR symbolic chart are said to be *direct*.

On Thursday, 04 April 1968, Martin Luther King Jr. was assassinated. Having found pertinent primary directions at the natal-chart level (in Section 4.5), let’s apply Technique #PD2 together with hindsight in order to look for pertinent primary directions at the SR-chart level. From Tuesday, 16 January 1968 (the SR date) to Thursday, 04 April 1968 (the date of King’s passing), there are 79 mean solar days. On applying Technique #PD2 for  $D = 79$ , we get

$$(3.93167189 \times D) \text{ min} \approx 310.60208 \text{ min} \approx 5 \text{ hr} + 10 \text{ min} + 36 \text{ sec}$$

as the chart-change term with respect to the SR chart (FIGURE 4.6a).

For the pre-SR symbolic chart (FIGURE 4.6b), we subtract the chart-change term (5 hours, 10 minutes, and 36 seconds) from the SR time of 01:00:30 pm, EST, thereby getting 07:49:54 am, EST. In this symbolic chart, we are looking for neo-converse primary directions that are associated with King’s life around the date of his passing. These are major planet-to-angle aspects having a margin of inexactness of about  $01^\circ$ . In this regard, we find a Sun-PC1 conjunction.

In the pre-SR symbolic chart, the Sun-PC1 conjunction is a neo-converse primary direction that may refer to King’s passing. Accidentally speaking, Sun is the lord of SR Leo 5th House (personal interests). Intrinsically speaking, Sun is the natural representative of becoming energized. Regarding house location, Sun lies in the intersection of SR Capricorn 10th House (achieving something significant) and SR PH9 (spiritual or professional know-how). In light of the foregoing, Sun refers to King’s spiritual achievements as being energized. PC1 (the Ascendant) refers to bodily life or bodily health. The conjunction aspect here refers to King’s spiritual achievements as being given new life. But how does this conjunction refer to King’s passing?

Let’s look at Sun within the pre-SR symbolic chart. Accidentally speaking, Sun is the lord of pre-SR Leo 8th House (bodily death). Intrinsicly speaking, Sun is the natural representative of becoming energized. Regarding house location, Sun lies in the intersection of pre-SR Capricorn 1st House (bodily life or bodily health) and pre-SR PH12 (hidden enemies). In light of the foregoing, Sun refers to bodily death as a result of hidden enemies. On putting it all together, Sun refers to King’s spiritual achievements as being energized as a result of his bodily death at the hands of hidden enemies. Therefore, the conjunction aspect here refers to King’s spiritual achievements as being given new life as a result of his bodily death.

By trial and error, we find that the Sun-PC1 conjunction becomes exact at about 07:46:43 am, EST on Tuesday, 16 January 1968 (the SR date). From 07:46:43 am, EST to 01:00:30 pm, EST (the SR time), the time difference is

$$\text{elapsed time} = 5 \text{ hr} + 13 \text{ min} + 47 \text{ sec} \approx 313.78333 \text{ min} .$$

On making use of the SR time-key, this time difference corresponds to an age difference of

$$\text{elapsed age} \approx \frac{1 \text{ day of age}}{3.93167189 \text{ min}} \times 313.78333 \text{ min} \approx 79.80913 \text{ days} ,$$

and so the neo-converse Sun-PC1 conjunction predicts an event to occur about 80 days after Tuesday, 16 January 1968 (the SR date), which is on Friday, 05 April 1968.

In Section B3 of Appendix B, we apply the primary-direction formula to the converse Sun-PC1 conjunction. On taking it to be traditionally converse, we get a prediction date of Thursday, 02 May 1968. On taking it to be neo-converse, we get a prediction date of Friday, 05 April 1968.

For the post-SR symbolic chart (FIGURE 4.6c), we add the chart-change term (5 hours, 10 minutes, and 36 seconds) to the SR time of 01:00:30 pm, EST, thereby getting 06:11:06 pm, EST. In this symbolic chart, we are looking for direct primary directions that are associated with King’s life around the date of his passing. These are major planet-to-angle aspects having a margin of inexactness of about 01°. In this regard, we find nothing.

## 4.7 King’s passing: LR primary directions

The native’s **lunar return** (LR) is Moon’s monthly return to its natal position. A lunar-return month spans the time interval from one lunar return to the next one. A **lunar-return chart** is a transit chart that is cast for the time when a lunar return occurs, and we take it to represent the entire associated lunar-return month.

On Thursday, 04 April 1968, Martin Luther King Jr. passed away. Let’s cast the lunar-return chart for King around April 1968. In the natal chart, Moon’s tropical ecliptic longitude is 349° 35' 11". The *ayanāṃśa* on King’s date of birth is 22° 51' 05" according to True Chitrā 0° Libra. On subtracting this *ayanāṃśa* from Moon’s tropical ecliptic longitude, we get 326° 44' 06", which is Moon’s sidereal ecliptic longitude in the natal chart. Around April 1968, Moon’s sidereal ecliptic longitude is 326° 44' 06" on Wednesday, 27 March 1968 at 06:27:08 am, EST. FIGURE 4.7a presents King’s last LR chart in terms of sidereal whole-sign houses. The *ayanāṃśa* on the LR date is 23° 24' 13" according to True Chitrā 0° Libra.

Let’s adapt Technique #PD1 (of Section 4.5) for use with lunar-return charts. The **LR time-key** is the notion that each degree of Earth’s axial rotation corresponds to each degree of Moon’s orbital motion. It follows that every addition of about 52.5615233 minutes to the LR time symbolically advances the LR chart by one mean solar day of age. See Section A5 of Appendix A for pertinent details. Here is our technique for LR primary directions:

- **TECHNIQUE #PD3:** In order to examine the native’s life around  $D$  mean solar days after the LR date, cast symbolic charts for about  $(52.5615233 \times D)$  minutes before and after the LR time. In these symbolic charts, look for major planet-to-angle aspects, taking the margin of inexactness to be about  $01^\circ$ . These major aspects are primary directions that each predict an event to occur in the native’s life around  $D$  days after the LR date.

The primary directions that are shown in the pre-LR symbolic chart are said to be *neo-converse*. The primary directions that are shown in the post-LR symbolic chart are said to be *direct*.

On Thursday, 04 April 1968, Martin Luther King Jr. was assassinated. Having found pertinent primary directions firstly at the natal-chart level (in Section 4.5) and secondly at the SR-chart level (in Section 4.6), let’s apply Technique #PD3 together with hindsight in order to look for pertinent primary directions at the LR-chart level. From Wednesday, 27 March 1968 (the LR date) to Thursday, 04 April 1968 (the date of King’s passing), there are 8 mean solar days. On applying Technique #PD3 for  $D = 8$ , we get

$$(52.5615233 \times D) \text{ min} \approx 420.49219 \text{ min} \approx 7 \text{ hr} + 0 \text{ min} + 30 \text{ sec}$$

as the chart-change term with respect to the LR chart (FIGURE 4.7a).

For the pre-LR symbolic chart (FIGURE 4.7b), we subtract the chart-change term (7 hours, 0 minutes, and 30 seconds) from the LR time of 06:27:08 am, EST, thereby getting 11:26:38 pm,

EST on the previous day. In this symbolic chart, we are looking for neo-converse primary directions that are associated with King’s life around March/April 1968. These are major planet-to-angle aspects having a margin of inexactness of about 01°. In this regard, we find a Moon-PC4 conjunction.

For the post-LR symbolic chart (FIGURE 4.7c), we add the chart-change term (7 hours, 0 minutes, and 30 seconds) to the LR time of 06:27:08 am, EST, thereby getting 01:27:38 pm, EST. In this symbolic chart, we are looking for direct primary directions that are associated with King’s life around March/April 1968. These are major planet-to-angle aspects having a margin of inexactness of about 01°. In this regard, we find a Mars-PC1 square.

In the post-LR symbolic chart, the Mars-PC1 square is a direct primary direction that may refer to King’s passing. Accidentally speaking, Mars is the lord of LR Aries 2nd House (supportive persons or things) and LR Scorpio 9th House (supportive factors to bodily death). Note that we are viewing the 9th House here as the derived 8th House (bodily death) with respect to the 2nd House (supportive persons or things). Intrinsically speaking, Mars is the natural representative of hostile action and bodily injury. In light of the foregoing, Mars refers to bodily death as a result of violence and bodily injury. PC1 (the Ascendant) refers to bodily life or bodily health. The square aspect here refers to Mars bringing PC1 into line with its agenda of bodily death.

By trial and error, we find that the Mars-PC1 square becomes exact at about 01:27:43 pm, EST on Wednesday, 27 March 1968 (the LR date). From 06:27:08 am, EST (the LR time) to 01:27:43 pm, EST, the time difference is

$$\text{elapsed time} = 7 \text{ hr} + 0 \text{ min} + 35 \text{ sec} \approx 420.58333 \text{ min} .$$

On making use of the LR time-key, this time difference corresponds to an age difference of

$$\text{elapsed age} \approx \frac{1 \text{ day of age}}{52.5615233 \text{ min}} \times 420.58333 \text{ min} \approx 8.00173 \text{ days},$$

and so the direct Mars-PC1 square conjunction predicts an event to occur about 8 days after Wednesday, 27 March 1968 (the LR date), which is on Thursday, 04 April 1968.

In Section B4 of Appendix B, we apply the primary-direction formula to the direct Mars-PC1 square, thereby getting a prediction date of Thursday, 04 April 1968.

## 4.8 Birth-time rectification

The verb ‘rectify’ means ‘to make right’. **Birth-time rectification** is the process of adjusting the native’s time of birth so that suitable planetary patterns coincide with actual life events. In this section, we will use three events of King’s life in order to rectify his birth time. In this regard, we will be taking ‘suitable planetary patterns’ to mean major planet-to-angle primary directions according to Technique #PD1 (of Section 4.5).

\*\*\*

### EVENT #1 (KING’S WEDDING DAY)

On Thursday, 18 June 1953, Martin Luther King Jr. married Coretta Scott, who would later become a civil-rights leader in her own right. By his wedding day, King had lived through 6 leap days (namely, those of 1932, 1936, 1940, 1944, 1948, and 1952). It follows that on his wedding day, King’s sidereal age was about

$$\frac{[(6 \times 366) + (18 \times 365) + 16 + 28 + 31 + 30 + 31 + 18] \text{ days}}{365.256363 \text{ days/yr}} \approx 24.42120 \text{ yrs.}$$

On applying Technique #PD1 for  $A \approx 24.42120$ , we get

$$(3.93167189 \times A) \text{ min} \approx 96.01615 \text{ min} \approx 1.60027 \text{ hr} \\ \approx 1 \text{ hr} + 36 \text{ min} + 1 \text{ sec}$$

as the chart-change term.

On adding this chart-change term to 12:00:00 CST (King's assumed birth time), we get 13:36:01 CST on Tuesday, 15 January 1929 (King's date of birth). In the post-birth symbolic chart cast for this time, we find a Mars-PC10 trine that becomes exact at about 13:35:31 CST (about 13.59194 hr CST).

Accidentally speaking, Mars is the lord of natal Aries 1st House (the native's well-being) and natal Scorpio 8th House (an ending that facilitates transformation). Intrinsically speaking, Mars is the natural representative of energetic assertive action. Regarding house location, Mars lies in the intersection of natal Taurus 2nd House and natal PH2, both houses referring to supportive persons or things. In light of the foregoing, Mars refers to transformative, energetic, assertive action that brings the native helpful support. PC10 refers to achieving something significant and to gaining prestige. The trine aspect here refers to Mars as being helpful to PC10.

## EVENT #2 (KING'S DC SPEECH)

On Wednesday, 28 August 1963, Martin Luther King Jr. delivered his famous "I Have A Dream" speech during the March on Washington for Jobs and Freedom. By the date of his speech, King had lived through 8 leap days (namely, those of 1932, 1936, 1940, 1944, 1948, 1952, 1956, and 1960). It follows that on the date of his speech, King's sidereal age was about

$$\frac{[(8 \times 366) + (26 \times 365) + 16 + 28 + 31 + 30 + 31 + 30 + 31 + 28] \text{ days}}{365.256363 \text{ days/yr}} \\ \approx 34.61405 \text{ yrs.}$$

On applying Technique #PD1 for  $A \approx 34.61405$ , we get

$$(3.93167189 \times A) \text{ min} \approx 136.09109 \text{ min} \approx 2.26819 \text{ hr} \\ \approx 2 \text{ hr} + 16 \text{ min} + 6 \text{ sec}$$

as the chart-change term.

On subtracting this chart-change term from 12:00:00 CST (King's assumed birth time), we get 09:43:54 CST on Tuesday, 15 January 1929 (King's date of birth). In the pre-birth symbolic chart cast for this time, we find a Saturn-PC10 conjunction that becomes exact at about 09:38:50 CST (about 9.64722 hr CST).

Accidentally speaking, Saturn is the lord of natal Aquarius 11th House (comrades and shared interests) and natal Capricorn 10th House (one's calling or career; achieving something significant; gaining prestige; head persons). Intrinsically speaking, Saturn is the natural representative of sober-minded action. Regarding house location, Saturn lies in the intersection of natal Sagittarius 9th House (spiritual or professional know-how) and natal PH8 (an ending that facilitates transformation). In light of the foregoing, Saturn refers to transformative, sober-minded, spiritual efforts of leadership that furthers the common good. PC10 refers to achieving something significant and to gaining prestige. The conjunction aspect here refers to Saturn as being helpful to PC10.

### EVENT #3 (KING'S PASSING)

On Thursday, 04 April 1968, Martin Luther King Jr. passed away in Memphis, Tennessee. See Section 4.5 for pertinent details of this event. We found that King's sidereal age on the event date is about 39.21629 yrs. Moreover, on applying Technique #PD1 for  $A \approx 39.21629$ , we got

$$154.18559 \text{ min} \approx 2.56976 \text{ hr} \approx 2 \text{ hr} + 34 \text{ min} + 11 \text{ sec}$$

as the chart-change term.

On subtracting the chart-change term from 12:00:00 CST (King's assumed birth time), we got 09:25:49 CST on Tuesday, 15 January 1929 (King's date of birth). In the pre-birth symbolic chart cast for this time, we found a Mars-PC4 conjunction that becomes exact at about 09:23:58 CST (about 9.39944 hr CST). On adding the chart-change term to 12:00:00 CST (King's assumed birth time), we got 14:34:11 CST. In the post-birth symbolic chart cast for this time, we found a Saturn-PC7 conjunction that becomes exact at about 14:30:59 CST (about 14.51639 hr CST).

\*\*\*

### LINEAR REGRESSION

Our process of rectifying the birth time is based on the model equation

$$y = x + b ,$$

whose graph is a straight line having a slope value of 1 and an intercept value of  $b$ . For the native at  $A$  sidereal years of age, the quantity  $x$  is the chart-addition term, which is given by

$$x = \begin{cases} -(3.93167189 \times A) \text{ min} & \text{for a pre-birth symbolic chart} \\ +(3.93167189 \times A) \text{ min} & \text{for a post-birth symbolic chart} . \end{cases}$$

It is advisable here to express  $x$  in hours. For a given value of  $x$ , the quantity  $y$  is the time at which an associated primary direction becomes exact. The constant  $b$  is the rectified birth time. It is advisable here to express  $y$  and  $b$  in hours according to the 24-hour time format. TABLE 4.8 presents the  $xy$  pairs pertaining to our three events of interest.

Each  $xy$  pair in the table is a data point. The technique of linear regression enables us to find the straight line that best accommodates our four data points. In this regard, we find that the equation of our best line is

$$y \approx (1.00437308)x + 11.9564577 .$$

On comparing this equation with the model equation  $y = x + b$ , we see that 1.00437308 (the best-line's slope) approximates the number 1 (the model-line's slope). Moreover, we see that 11.9564577 (the best-line's intercept) approximates  $b$  (the model-line's intercept):

$$b \approx 11.9564577 \text{ hr} \approx 11 \text{ hr} + 57 \text{ min} + 23 \text{ sec} .$$

Therefore, King's rectified birth time is about 11:57:23 am, CST. The birth-time rectification here is based on four data points. The more data points that we use for the linear regression, the better we can adjust the birth time.

**IMPORTANT COMMENTS:** We may use the process of birth-time rectification to not only adjust an assumed birth time, but also to determine an unknown birth time. Our process here depends on finding an adequate number of suitable primary directions.

Note that the horizon angles are the Ascendant and the Descendant, while the meridian angles are the Midheaven and the Imum Coeli.

## A1 Equatorial coordinates

[\[Back to Appendix A\]](#)

The **method of primary directions** is a technique that uses primary motion to predict events. In order to deal with the mathematics of primary directions, we will use the **equatorial coordinate system**, which enables us to specify the location of any point of the celestial sphere in terms of pertinent values of longitude and latitude. Equatorial longitude (called **right ascension**) is angular distance measured along the equator, going from  $0^\circ$  to  $360^\circ$  as we go eastward from the March equinox point. Equatorial latitude (called **declination**) is angular distance (along the celestial sphere) from the equator, going from  $0^\circ$  to  $+90^\circ$  as we go perpendicularly northward and going from  $0^\circ$  to  $-90^\circ$  as we go perpendicularly southward.

Converting from sidereal ecliptic coordinates to equatorial coordinates involves converting sidereal ecliptic coordinates to tropical ecliptic coordinates and then to equatorial coordinates. Adding the *ayanāmśa* to a sidereal ecliptic longitude yields its equivalent tropical ecliptic longitude, while tropical ecliptic latitude equals sidereal ecliptic latitude. See Section 2.1 for pertinent details.

Both tropical ecliptic longitude and right ascension are measured from the March equinox point. Going from tropical ecliptic coordinates to equatorial coordinates is a conversion from one system of spherical coordinates to another. Consider a point of the celestial sphere that has tropical ecliptic longitude  $\lambda$  and ecliptic latitude  $\beta$ . Its right ascension  $RA$  and declination  $\delta$  satisfy the equations

$$\begin{aligned}\cos \delta \times \cos(RA) &= \cos \beta \times \cos \lambda , \\ \cos \delta \times \sin(RA) &= \cos \varepsilon \times \cos \beta \times \sin \lambda - \sin \varepsilon \times \sin \beta , \\ \sin \delta &= \sin \varepsilon \times \cos \beta \times \sin \lambda + \cos \varepsilon \times \sin \beta ,\end{aligned}$$

where the **obliquity**  $\varepsilon$  is the angle between the ecliptic plane and the celestial equatorial plane (which is the same as Earth’s equatorial plane). The obliquity is a slowly varying angle that is currently about  $23^\circ 26' 09'' \approx 23.43583^\circ$ . We find that

$$\delta = \arcsin(\sin \varepsilon \times \cos \beta \times \sin \lambda + \cos \varepsilon \times \sin \beta).$$

On defining the **equinoctial distance**

$$ED := \arccos\left(\frac{\cos \beta \times \cos \lambda}{\cos \delta}\right),$$

we get

$$RA = \begin{cases} ED & \text{for } \lambda < 180^\circ \\ 360^\circ - ED & \text{for } \lambda > 180^\circ. \end{cases}$$

Note that equinoctial distance is angular distance measured along the equator, going from  $0^\circ$  to  $180^\circ$  as we go eastward or westward from the March equinox point.

In order to get the ecliptic latitude of an aspect copy, we will use the **Bianchini aspect circle**. On the celestial sphere, this great circle passes through the parent planet’s location and intersects the ecliptic at the two points corresponding to the planet’s square aspects. In this regard, we will take each square copy to lie on the ecliptic at an intersection point, and we will take the opposition copy to lie at the point that is opposite the parent planet’s location. It follows that the ecliptic latitude of an aspect copy having signature angular separation  $\theta_A$  is given by

$$\beta_A = \beta_0 \times \cos \theta_A$$

where  $\beta_0$  is the ecliptic latitude of the parent planet. TABLE A1 presents pertinent results.

## A2 The primary-direction formula

Earth’s axial rotation gives rise to primary motion. From the point of view of an earthbound observer, we may view primary motion as causing the zodiacal belt (with the planets attached to it) to rotate backward through fixed houses of the local sky. It is useful here to imagine two celestial spheres that occupy the same volume of space – the active sphere and the fixed sphere. The **active sphere** is the celestial sphere undergoing its usual axial rotation according to primary motion. The **fixed sphere** is the celestial sphere as it appeared at a specific time of interest, which

could be a birth time, a solar-return time, or a lunar-return time. Primary motion moves the active sphere across the stationary fixed sphere.

In applying the method of primary directions, primary motion directs a given point of the active sphere backward through the houses toward a given point of the fixed sphere. One of these two points is called the **significator**, and it indicates the area of life in which the predicted event will occur. The other point is called the **promissor**, and it indicates that which promises (that is, gives grounds for expecting) the predicted event. A primary direction is said to be **direct** if primary motion directs a promissor lying in the active sphere toward a significator lying in the fixed sphere. A primary direction is said to be **traditionally converse** if primary motion directs a significator lying in the active sphere toward a promissor lying in the fixed sphere. A primary direction is said to be **neo-converse** if reversed primary motion (which is a what-if notion) directs a promissor lying in the active sphere toward a significator lying in the fixed sphere.

The **arc of direction** is the circular path along which primary motion directs the active point (which lies in the active sphere) toward the fixed point (which lies in the fixed sphere). The length of the arc of direction is related to the time when the associated event is predicted to occur in the native's life. For primary directions that are direct or traditionally converse, this arc length is given by the **primary-direction formula**

$$\text{arc length} = \begin{cases} (RA)_A - (RA)_F - R_F \times [(AD)_A - (AD)_F] & \text{for an eastern fixed point} \\ (RA)_A - (RA)_F + R_F \times [(AD)_A - (AD)_F] & \text{for a western fixed point,} \end{cases}$$

where the subscripts  $A$  and  $F$  respectively refer to the active point and the fixed point. The **ascensional difference**  $AD$  is given by

$$AD := \arcsin(\tan \delta \times \tan \Phi),$$

where  $\Phi$  is the native's geographical latitude of birth. Note that geographical latitude is angular distance (along Earth's surface) from the equator, going from  $0^\circ$  to  $+90^\circ$  as we go perpendicularly northward and going from  $0^\circ$  to  $-90^\circ$  as we go perpendicularly southward. The nonnegative quantity

$$R_F = \left| \frac{(MD)_F}{(SA)_F} \right|$$

involves the ratio of the fixed-point's **meridian distance**

$$(MD)_F = \begin{cases} (RA)_F - (RA)_{MC} & \text{for a fixed point in the upper sky} \\ (RA)_F - (RA)_{IC} & \text{for a fixed point in the lower sky} \end{cases}$$

to its **semi-arc**

$$(SA)_F = \begin{cases} 90^\circ + (AD)_F & \text{for a fixed point in the upper sky} \\ 90^\circ - (AD)_F & \text{for a fixed point in the lower sky.} \end{cases}$$

Note that  $R_F$  must not exceed the value of 1.

For a neo-converse primary direction, we use the negative of the arc-length formula that we would get if the primary direction were direct.

## A3 Directing toward a horizon angle

Whenever a planet is just rising during its daily cycle, primary motion has brought it to the Ascendant. For a direct primary direction having the Ascendant as the significator, the eastern Ascendant is the fixed point, and so the primary-direction formula yields

$$\text{arc length} = (RA)_P - (RA)_{Asc} - R_{Asc} \times [(AD)_P - (AD)_{Asc}],$$

where the subscript  $P$  refers to the promissor.

The Ascendant is on the horizon, but if we were to take it to be slightly above the horizon, then we would have

$$R_{Asc} = \left| \frac{(RA)_{Asc} - (RA)_{MC}}{90^\circ + (AD)_{Asc}} \right|.$$

The **oblique ascension**  $OA$  is given by

$$OA = RA - AD.$$

On making use of the expression

$$(OA)_{Asc} = (RA)_{MC} + 90^\circ,$$

we get

$$\begin{aligned} \frac{(RA)_{Asc} - (RA)_{MC}}{90^\circ + (AD)_{Asc}} &= \frac{(RA)_{Asc} - [(OA)_{Asc} - 90^\circ]}{90^\circ + (AD)_{Asc}} = \frac{90^\circ + [(RA)_{Asc} - (OA)_{Asc}]}{90^\circ + (AD)_{Asc}} \\ &= \frac{90^\circ + (AD)_{Asc}}{90^\circ + (AD)_{Asc}} = 1, \end{aligned}$$

and so  $R_{Asc} = |1| = 1$ .

The Ascendant is on the horizon, but if we were to take it to be slightly below the horizon, then we would have

$$R_{Asc} = \left| \frac{(RA)_{Asc} - (RA)_{IC}}{90^\circ - (AD)_{Asc}} \right|.$$

If Point #1 and Point #2 are opposite points of the celestial sphere, then

$$(RA)_2 = (RA)_1 - 180^\circ \equiv (RA)_1 + 180^\circ,$$

$$\delta_2 = -\delta_1 \Rightarrow (AD)_2 = -(AD)_1.$$

Because the Midheaven and Imum Coeli are opposite points of the celestial sphere, we get

$$(RA)_{IC} = (RA)_{MC} - 180^\circ \equiv (RA)_{MC} + 180^\circ,$$

and so

$$\begin{aligned} \frac{(RA)_{Asc} - (RA)_{IC}}{90^\circ - (AD)_{Asc}} &= \frac{(RA)_{Asc} - [(RA)_{MC} + 180^\circ]}{90^\circ - (AD)_{Asc}} \\ &= \frac{(RA)_{Asc} - [(OA)_{Asc} - 90^\circ] - 180^\circ}{90^\circ - (AD)_{Asc}} = \frac{-90^\circ + [(RA)_{Asc} - (OA)_{Asc}]}{90^\circ - (AD)_{Asc}} \\ &= \frac{-90^\circ + (AD)_{Asc}}{90^\circ - (AD)_{Asc}} = \frac{-[90^\circ - (AD)_{Asc}]}{90^\circ - (AD)_{Asc}} = -1. \end{aligned}$$

Therefore, we get  $R_{Asc} = |-1| = 1$ .

Having shown that  $R_{Asc} = 1$ , we now have

$$\begin{aligned} \text{arc length} &= (RA)_P - (RA)_{Asc} - 1 \times [(AD)_P - (AD)_{Asc}] \\ &= [(RA)_P - (AD)_P] - [(RA)_{Asc} - (AD)_{Asc}], \end{aligned}$$

and so the expression

$$\text{arc length} = (OA)_P - (OA)_{Asc}$$

gives the arc length for a direct primary direction having the Ascendant as the significator.

Whenever a planet is just setting during its daily cycle, primary motion has brought it to the Descendant. For a direct primary direction having the Descendant as the significator, the western Descendant is the fixed point, and so the primary-direction formula yields

$$\text{arc length} = (RA)_P - (RA)_{Dsc} + R_{Dsc} \times [(AD)_P - (AD)_{Dsc}],$$

where the subscript  $P$  refers to the promissor.

The Descendant is on the horizon, but if we were to take it to be slightly above the horizon, then we would have

$$R_{Dsc} = \left| \frac{(RA)_{Dsc} - (RA)_{MC}}{90^\circ + (AD)_{Dsc}} \right|.$$

The **oblique descension**  $OD$  is given by

$$OD = RA + AD.$$

On making use of the expression

$$(OD)_{Dsc} = (RA)_{MC} - 90^\circ,$$

we get

$$\begin{aligned} \frac{(RA)_{Dsc} - (RA)_{MC}}{90^\circ + (AD)_{Dsc}} &= \frac{(RA)_{Dsc} - [(OD)_{Dsc} + 90^\circ]}{90^\circ + (AD)_{Dsc}} = \frac{-90^\circ - [(OD)_{Dsc} - (RA)_{Asc}]}{90^\circ + (AD)_{Asc}} \\ &= \frac{-90^\circ - (AD)_{Dsc}}{90^\circ + (AD)_{Dsc}} = -1, \end{aligned}$$

and so  $R_{Dsc} = |-1| = 1$ .

The Descendant is on the horizon, but if we were to take it to be slightly below the horizon, then we would have

$$R_{Dsc} = \left| \frac{(RA)_{Dsc} - (RA)_{IC}}{90^\circ - (AD)_{Dsc}} \right|.$$

On considering pertinent opposite points, we find that

$$\frac{(RA)_{Dsc} - (RA)_{IC}}{90^\circ - (AD)_{Dsc}} = \frac{[(RA)_{Asc} - 180^\circ] - [(RA)_{MC} - 180^\circ]}{90^\circ - [-(AD)_{Asc}]} = \frac{(RA)_{Asc} - (RA)_{MC}}{90^\circ + (AD)_{Asc}},$$

which we have already shown to be equal to 1. Therefore, we get  $R_{Dsc} = |1| = 1$ .

Having shown that  $R_{Dsc} = 1$ , we now have

$$\begin{aligned} \text{arc length} &= (RA)_P - (RA)_{Dsc} + 1 \times [(AD)_P - (AD)_{Dsc}] \\ &= [(RA)_P + (AD)_P] - [(RA)_{Dsc} + (AD)_{Dsc}], \end{aligned}$$

and so the expression

$$\text{arc length} = (OD)_P - (OD)_{Dsc}$$

gives the arc length for a direct primary direction having the Descendant as the significator. Let's go further. For the point  $Q$  that is opposite the promissor, we have

$$(RA)_Q = (RA)_P - 180^\circ \equiv (RA)_P + 180^\circ, \quad (AD)_Q = -(AD)_P,$$

and so

$$\begin{aligned} \text{arc length} &= [(RA)_P + (AD)_P] - [(RA)_{Dsc} + (AD)_{Dsc}] \\ &= [(RA)_Q + 180^\circ - (AD)_Q] - [(RA)_{Asc} + 180^\circ - (AD)_{Asc}] \\ &= [(RA)_Q - (AD)_Q] - [(RA)_{Asc} - (AD)_{Asc}]. \end{aligned}$$

It follows that

$$\text{arc length} = (OA)_Q - (OA)_{Asc},$$

and so for a direct primary direction having the Descendant as the significator, we may consider the situation in which the promissor's opposite point reaches the Ascendant.

## A4 Directing toward a meridian angle

[\[Back to Appendix A\]](#)

Whenever a planet culminates during its daily cycle, primary motion has brought it to the Midheaven. For a direct primary direction having the Midheaven as the significator, the primary-direction formula yields

$$\text{arc length} = (RA)_P - (RA)_{MC} \mp R_{MC} \times [(AD)_P - (AD)_{MC}],$$

where the subscript  $P$  refers to the promissor.

Because the Midheaven is in the upper sky, we have

$$R_{MC} = \left[ \frac{(RA)_{MC} - (RA)_{MC}}{90^\circ + (AD)_{MC}} \right] = 0,$$

and so the expression

$$\text{arc length} = (RA)_P - (RA)_{MC}$$

gives the arc length for a direct primary direction having the Midheaven as the significator.

Whenever a planet anti-culminates during its daily cycle, primary motion has brought it to the Imum Coeli. For a direct primary direction having the Imum Coeli as the significator, the primary-direction formula yields

$$\text{arc length} = (RA)_P - (RA)_{IC} \mp R_{IC} \times [(AD)_P - (AD)_{IC}],$$

where the subscript  $P$  refers to the promissor.

Because the Imum Coeli is in the lower sky, we have

$$R_{IC} = \left[ \frac{(RA)_{IC} - (RA)_{IC}}{90^\circ - (AD)_{IC}} \right] = 0,$$

and so the expression

$$\text{arc length} = (RA)_P - (RA)_{IC}$$

gives the arc length for a direct primary direction having the Imum Coeli as the significator. Let's go further. We find that

$$\begin{aligned} \text{arc length} &= (RA)_P - (RA)_{IC} = [(RA)_P - 180^\circ] - [(RA)_{MC} - 180^\circ] \\ &= (RA)_Q - (RA)_{MC}, \end{aligned}$$

and so for a direct primary direction having Imum Coeli as the significator, we may consider the situation in which the promissor's opposite point reaches the Midheaven.

## A5 Time-keys

In order to convert the length of the arc of direction into the time when the predicted event occurs, we need a time-key. The Ptolemy and Naibod time-keys are useful when applying the method of primary directions to a natal chart.

A **sidereal day** is the time taken by Earth to complete a single rotation relative to the fixed stars, and it consists of approximately 23 hours, 56 minutes, and 4.0905 seconds (which is about 1436.068175 minutes). A sidereal day is a few minutes short of a **mean solar day** (the basis of the 24-hour civil day), which is the time taken by Earth to complete a single rotation and to advance about one degree along its orbital path about Sun. A **sidereal year** is the time taken by Earth to complete its orbit about Sun relative to the fixed stars, and it consists of 365 mean solar days, 6

hours, 9 minutes, and 9.8 seconds (which is about 365.256363 mean solar days). A **mean tropical year** is the time taken by Earth to complete its annual cycle of seasons, and it consists of 365 mean solar days, 5 hours, 48 minutes, and 45.1 seconds (which is about 365.242189 mean solar days).

Earth's axial rotation gives rise to primary motion. As Earth makes its daily 360° rotation about its axis, it moves at an angular rate of

$$\frac{360 \text{ deg}}{1436.068175 \text{ min}} \approx \frac{1 \text{ deg}}{3.98907826 \text{ min}},$$

and so it takes Earth about 3.98907826 minutes to longitudinally rotate by 01°. The **Ptolemy time-key** (named after the Hellenistic astrologer Claudius Ptolemy) is the notion that one degree of Earth's axial rotation corresponds to one sidereal year of age. Therefore, according to the Ptolemy time-key, each degree of the arc of direction corresponds to one sidereal year of age. Moreover, every addition of about 3.98907826 minutes to the birth time symbolically advances the natal chart by one sidereal year of age.

An alternative approach was developed by the 16th-century German astrologer Valentine Naibod. As Earth makes its yearly 360° orbit about Sun, it moves at an angular rate of

$$\frac{360 \text{ deg}}{365.256363 \text{ days}} \approx \frac{0.985609113 \text{ deg}}{1 \text{ day}} \approx \frac{00^\circ 59' 08.19''}{1 \text{ day}}.$$

We may view Earth's yearly 360° orbit as a sequence of nearly 365 steps, each of 0.985609113 *deg*. We may similarly view Earth's daily 360° axial rotation as a sequence of nearly 365 steps, each of 0.985609113 *deg*. Here we are viewing 0.985609113 *deg* (about 00° 59' 08.19") as the basic step of Earth's angular motion, whether axial (daily cycle) or orbital (yearly cycle). The **Naibod time-key** is the notion that each 00° 59' 08.19" of Earth's axial rotation corresponds to one sidereal year of age. Therefore, according to the Naibod time-key, each 0.985609113 *deg* of the arc of direction corresponds to one sidereal year of age. In this regard, we find that

$$\frac{1 \text{ yr of age}}{0.985609113 \text{ deg}} \approx \frac{1.01460101 \text{ yrs of age}}{1 \text{ deg}},$$

and so each degree of the arc of direction corresponds to about 1.01460101 sidereal years of age.

It takes Earth about 3.98907826 minutes to longitudinally rotate by 01°, and so

$$0.985609113 \text{ deg} \times \frac{3.98907826 \text{ min}}{1 \text{ deg}} \approx 3.93167189 \text{ min}$$

is the time taken by Earth to longitudinally rotate by about 00° 59' 08.19". Therefore, according to the Naibod time-key, every addition of about 3.93167189 minutes to the birth time symbolically advances the natal chart by one sidereal year of age.

Let's now consider applying the method of primary directions to a solar-return (SR) chart. Primary motion is related to Earth's axial rotation, which has a time rate of

$$\frac{360 \text{ deg}}{1436.068175 \text{ min}} \approx \frac{1 \text{ deg}}{3.98907826 \text{ min}},$$

Solar returns are related to Earth's orbital motion about Sun, which has a time rate of

$$\frac{360 \text{ deg}}{365.256363 \text{ days}} \approx \frac{1 \text{ deg}}{1.01460101 \text{ days}}.$$

The **SR time-key** is the notion that each degree of Earth's axial rotation corresponds to each degree of Earth's orbital motion. Therefore, according to the SR time-key, each degree of the arc of direction corresponds to about 1.01460101 mean solar days of age. Moreover, every addition of about 3.98907826 minutes to the SR time symbolically advances the SR chart by 1.01460101 mean solar days of age. It follows that every addition of about 3.93167189 minutes to the SR time symbolically advances the SR chart by one mean solar day of age.

Let's now consider applying the method of primary directions to a lunar-return (LR) chart. Primary motion is related to Earth's axial rotation, which has a time rate of

$$\frac{360 \text{ deg}}{1436.068175 \text{ min}} \approx \frac{1 \text{ deg}}{3.98907826 \text{ min}}.$$

Lunar returns are related to Moon's orbital motion about Earth, which has a time rate of

$$\frac{360 \text{ deg}}{27.3216620 \text{ days}} \approx \frac{1 \text{ deg}}{0.0758935056 \text{ day}}.$$

Note that a **sidereal month** consists of 27 mean solar days, 7 hours, 43 minutes, and 11.6 seconds (which is about 27.3216620 mean solar days). The **LR time-key** is the notion that each degree of Earth's axial rotation corresponds to each degree of Moon's orbital motion. Therefore, according to the LR time-key, each degree of the arc of direction corresponds to about 0.0758935056 mean solar days of age. Moreover, every addition of about 3.98907826 minutes to the LR time symbolically advances the LR chart by 0.0758935056 mean solar days of age. It follows that every addition of about 52.5615233 minutes to the LR time symbolically advances the LR chart by one mean solar day of age.

Note that the denotation ‘PC*n*’ refers to the cusp of Porphyry House *n*.

### B1 The natal Mars-PC4 conjunction

FIGURE B1 presents King’s natal chart in terms of tropical whole-sign houses. Regarding this chart, the Mars-PC4 conjunction is a converse primary direction in which Mars is the promissor and PC4 (the Imum Coeli) is the significator.

If we take the Mars-PC4 conjunction to be traditionally converse, then the fixed point is Mars, which lies in the lower eastern sky. For this situation, we have

$$\text{arc length} = (RA)_{IC} - (RA)_P - R_P \times [(AD)_{IC} - (AD)_P],$$

where

$$R_P = \left| \frac{(RA)_P - (RA)_{IC}}{90^\circ - (AD)_P} \right|.$$

Note that the subscript *P* refers to the promissor.

If we take the Mars-PC4 conjunction to be neo-converse, then the fixed point is the Imum Coeli, which lies in the lower sky. Here we use the negative of the arc-length formula that we would get if the primary direction were direct, and so

$$\text{arc length} = -[(RA)_P - (RA)_{IC}] = (RA)_{IC} - (RA)_P,$$

where the subscript *P* refers to the promissor.

Firstly, let's deal with Mars. In the tropical natal chart (FIGURE B1), Mars is at Gemini 21° 53' 50'' with an ecliptic latitude of +03° 26' 17''. Therefore, we have

$$\lambda_p = 81^\circ 53' 50'' \approx 81.89722^\circ, \quad \beta_p = +03^\circ 26' 17'' \approx +3.43806^\circ.$$

We find that Mars's declination is

$$\begin{aligned} \delta_p &= \arcsin(\sin \varepsilon \times \cos \beta_p \times \sin \lambda_p + \cos \varepsilon \times \sin \beta_p) \\ &\approx \arcsin[\sin 23.43583^\circ \times \cos(+3.43806^\circ) \times \sin 81.89722^\circ \\ &\quad + \cos 23.43583^\circ \times \sin(+3.43806^\circ)] \\ &\approx +26.61960^\circ. \end{aligned}$$

The equinoctial distance here is

$$\begin{aligned} (ED)_p &= \arccos\left(\frac{\cos \beta_p \times \cos \lambda_p}{\cos \delta_p}\right) \approx \arccos\left[\frac{\cos(+3.43806^\circ) \times \cos 81.89722^\circ}{\cos(+26.61960^\circ)}\right] \\ &\approx 80.94529^\circ. \end{aligned}$$

Because  $\lambda_p < 180^\circ$ , we get  $(RA)_p = (ED)_p \approx 80.94529^\circ$  as Mars's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . We find that

$$\begin{aligned} (AD)_p &= \arcsin(\tan \delta_p \times \tan \Phi) \approx \arcsin[\tan(+26.61960^\circ) \times \tan(+33.75^\circ)] \\ &\approx 19.56554^\circ \end{aligned}$$

is Mars's ascensional difference.

Secondly, let's deal with PC4 (the Imum Coeli). In the tropical natal chart (FIGURE B1), the Midheaven is at Capricorn 28° 12' 25" with an ecliptic latitude of 0° exactly. Therefore, we have

$$\lambda_{MC} = 298^\circ 12' 25'' \approx 298.20694^\circ, \quad \beta_{MC} = 0^\circ.$$

We find that the Midheaven's declination is

$$\begin{aligned} \delta_{MC} &= \arcsin(\sin \varepsilon \times \cos \beta_{MC} \times \sin \lambda_{MC} + \cos \varepsilon \times \sin \beta_{MC}) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 298.20694^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx -20.51734^\circ. \end{aligned}$$

The equinoctial distance here is

$$\begin{aligned} (ED)_{MC} &= \arccos\left(\frac{\cos \beta_{MC} \times \cos \lambda_{MC}}{\cos \delta_{MC}}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 298.20694^\circ}{\cos(-20.51734^\circ)}\right] \\ &\approx 59.69050^\circ. \end{aligned}$$

Because  $\lambda_{MC} > 180^\circ$ , we get  $(RA)_{MC} = 360^\circ - (ED)_{MC} \approx 300.30950^\circ$  as the Midheaven's right ascension. Because the Midheaven and the Imum Coeli are opposite points, we have

$$\begin{aligned} (RA)_{IC} &= (RA)_{MC} - 180^\circ \approx 300.30950^\circ - 180^\circ = 120.30950^\circ, \\ \delta_{IC} &= -\delta_{MC} \approx +20.51734^\circ. \end{aligned}$$

King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . We find that

$$\begin{aligned} (AD)_{IC} &= \arcsin(\tan \delta_{IC} \times \tan \Phi) \approx \arcsin[\tan(+20.51734^\circ) \times \tan(+33.75^\circ)] \\ &\approx 14.48061^\circ \end{aligned}$$

is the Imum Coeli's ascensional difference.

Thirdly, let's deal with the ratio  $R_p$ . We find that

$$R_p = \left| \frac{(RA)_P - (RA)_{IC}}{90^\circ - (AD)_P} \right| \approx \left| \frac{80.94529^\circ - 120.30950^\circ}{90^\circ - 19.56554^\circ} \right| \approx 0.55888.$$

Note that  $R_p$  must not exceed the value of 1.

Now we are ready to deal with the arc of direction for the converse Mars-PC4 conjunction. If we take the Mars-PC4 conjunction to be traditionally converse, then

$$\begin{aligned} \text{arc length} &= (RA)_{IC} - (RA)_P - R_p \times [(AD)_{IC} - (AD)_P] \\ &\approx 120.30950^\circ - 80.94529^\circ - 0.55888 \times (14.48061^\circ - 19.56554^\circ) \\ &\approx 42.20608^\circ. \end{aligned}$$

According to the Naibod time-key, this arc indicates

$$42.20608 \text{ deg} \times \frac{1.01460101 \text{ yrs of age}}{1 \text{ deg}} \approx 42.82233 \text{ yrs of age},$$

and so the traditionally converse Mars-PC4 conjunction predicts an event to occur sometime in 1971, which is greatly after King's passing on Thursday, 04 April 1968.

If we take the Mars-PC4 conjunction to be neo-converse, then

$$\text{arc length} = (RA)_{IC} - (RA)_P \approx 120.30950^\circ - 80.94529^\circ = 39.36421^\circ .$$

According to the Naibod time-key, this arc indicates

$$\begin{aligned} & 39.36421 \text{ deg} \times \frac{1.01460101 \text{ yrs of age}}{1 \text{ deg}} \approx 39.93897 \text{ yrs of age} \\ & = 39 \text{ yrs} + \left( 0.93897 \text{ yr} \times \frac{365.256363 \text{ days}}{1 \text{ yr}} \right) \approx 39 \text{ yrs} + 342.96477 \text{ days} , \end{aligned}$$

and so the neo-converse Mars-PC4 conjunction predicts an event to occur about 343 days after Monday, 15 January 1968 (King's 39th birthday), which is on Monday, 23 December 1968 (Day 358 of 1968).

## B2 The natal Saturn-PC7 conjunction

FIGURE B1 presents King's natal chart in terms of tropical whole-sign houses. Regarding this chart, the Saturn-PC7 conjunction is a direct primary direction in which Saturn is the promissor and PC7 (the Descendant) is the significator. For this situation, we have

$$\text{arc length} = (OD)_P - (OD)_{DSC} ,$$

where the subscript  $P$  refers to the promissor.

Firstly, let's deal with Saturn. In the tropical natal chart (FIGURE B1), Saturn is at Sagittarius  $25^\circ 21' 07''$  with an ecliptic latitude of  $+01^\circ 09' 56''$ . Therefore, we have

$$\lambda_P = 265^\circ 21' 07'' \approx 265.35194^\circ , \quad \beta_P = +01^\circ 09' 56'' \approx +1.16556^\circ .$$

We find that the copy's declination is

$$\begin{aligned} \delta_P &= \arcsin(\sin \varepsilon \times \cos \beta_P \times \sin \lambda_P + \cos \varepsilon \times \sin \beta_P) \\ &\approx \arcsin[\sin 23.43583^\circ \times \cos(+1.16556^\circ) \times \sin 265.35194^\circ \\ &\quad + \cos 23.43583^\circ \times \sin(+1.16556^\circ)] \\ &\approx -22.18933^\circ . \end{aligned}$$

The equinoctial distance here is

$$\begin{aligned} (ED)_P &= \arccos\left(\frac{\cos \beta_P \times \cos \lambda_P}{\cos \delta_P}\right) \approx \arccos\left[\frac{\cos(+1.16556^\circ) \times \cos 265.35194^\circ}{\cos(-22.18933^\circ)}\right] \\ &\approx 95.01970^\circ . \end{aligned}$$

Because  $\lambda_P > 180^\circ$ , we get  $(RA)_P = 360^\circ - (ED)_P \approx 264.98030^\circ$  as the copy's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . For the copy's ascensional difference, we get

$$(AD)_P = \arcsin(\tan \delta_P \times \tan \Phi) \approx \arcsin[\tan(-22.18933^\circ) \times \tan(+33.75^\circ)] \\ \approx -15.81508^\circ,$$

and so

$$(OD)_P = (RA)_P + (AD)_P \approx 264.98030^\circ + (-15.81508^\circ) = 249.16522^\circ$$

is the copy's oblique descension.

Secondly, let's deal with PC7 (the Descendant). In the tropical natal chart (FIGURE B1), the Descendant is at Scorpio  $13^\circ 48' 38''$  with an ecliptic latitude of  $0^\circ$  exactly. Therefore, we have

$$\lambda_{DSC} = 223^\circ 48' 38'' \approx 223.81056^\circ, \quad \beta_{DSC} = 0^\circ.$$

We find that the Descendant's declination is

$$\delta_{DSC} = \arcsin(\sin \varepsilon \times \cos \beta_{DSC} \times \sin \lambda_{DSC} + \cos \varepsilon \times \sin \beta_{DSC}) \\ \approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 223.81056^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ \approx -15.98188^\circ.$$

The equinoctial distance here is

$$(ED)_{DSC} = \arccos\left(\frac{\cos \beta_{DSC} \times \cos \lambda_{DSC}}{\cos \delta_{DSC}}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 223.81056^\circ}{\cos(-15.98188^\circ)}\right] \\ \approx 138.64637^\circ.$$

Because  $\lambda_{DSC} > 180^\circ$ , we get  $(RA)_{DSC} = 360^\circ - (ED)_{DSC} \approx 221.35363^\circ$  as the Descendant's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . For the Descendant's ascensional difference, we get

$$(AD)_{DSC} = \arcsin(\tan \delta_{DSC} \times \tan \Phi) \approx \arcsin[\tan(-15.98188^\circ) \times \tan(+33.75^\circ)] \\ \approx -11.03266^\circ,$$

and so

$$(OD)_{DSC} = (RA)_{DSC} + (AD)_{DSC} \approx 221.35363^\circ + (-11.03266^\circ) = 210.32097^\circ$$

is the Descendant's oblique descension.

Now we are ready to deal with the arc of direction for the direct Saturn-PC7 conjunction. We find that

$$\text{arc length} = (OD)_P - (OD)_{DSC} \approx 249.16522^\circ - 210.32097^\circ = 38.84425^\circ.$$

According to the Naibod time-key, this arc indicates

$$38.84425 \text{ deg} \times \frac{1.01460101 \text{ yrs of age}}{1 \text{ deg}} \approx 39.41142 \text{ yrs of age}$$

$$= 39 \text{ yrs} + \left( 0.41142 \text{ yr} \times \frac{365.256363 \text{ days}}{1 \text{ yr}} \right) \approx 39 \text{ yrs} + 150.27377 \text{ days},$$

and so the direct Saturn-PC7 conjunction predicts an event to occur about 150 days after Monday, 15 January 1968 (King’s 39th birthday), which is on Thursday, 13 June 1968 (Day 165 of 1968).

### B3 The SR Sun-PC1 conjunction

Regarding this chart, the Sun-PC1 conjunction is a converse primary direction in which Sun is the promissor and PC1 (the Ascendant) is the significator.

If we take the Sun-PC1 conjunction to be traditionally converse, then the fixed point is Sun, which lies in the upper western sky. For this situation, we have

$$\text{arc length} = (RA)_{ASC} - (RA)_P + R_P \times [(AD)_{ASC} - (AD)_P],$$

where

$$R_P = \left| \frac{(RA)_P - (RA)_{MC}}{90^\circ + (AD)_P} \right|.$$

Note that the subscript  $P$  refers to the promissor.

If we take the Sun-PC1 conjunction to be neo-converse, then the fixed point is the Ascendant, which lies in the eastern sky. Here we use the negative of the arc-length formula that we would get if the primary direction were direct, and so

$$\begin{aligned} \text{arc length} &= -[(OA)_P - (OA)_{Asc}] = (OA)_{Asc} - (OA)_P \\ &= [(RA)_{Asc} - (AD)_{Asc}] - [(RA)_P - (AD)_P] \\ &= (RA)_{Asc} - (RA)_P - [(AD)_{Asc} - (AD)_P], \end{aligned}$$

where the subscript  $P$  refers to the promissor.

Firstly, let's deal with Sun. In the tropical SR chart (FIGURE B3), Sun is at Capricorn  $25^\circ 40' 43''$  with an ecliptic latitude of  $0^\circ$  exactly. Therefore, we have

$$\lambda_P = 295^\circ 40' 43'' \approx 295.67861^\circ, \quad \beta_P = 0^\circ.$$

We find that Sun's declination is

$$\begin{aligned} \delta_P &= \arcsin(\sin \varepsilon \times \cos \beta_P \times \sin \lambda_P + \cos \varepsilon \times \sin \beta_P) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 295.67861^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx -21.00456^\circ. \end{aligned}$$

The equinoctial distance here is

$$\begin{aligned} (ED)_P &= \arccos\left(\frac{\cos \beta_P \times \cos \lambda_P}{\cos \delta_P}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 295.67861^\circ}{\cos(-21.00456^\circ)}\right] \\ &\approx 62.34377^\circ. \end{aligned}$$

Because  $\lambda_P > 180^\circ$ , we get  $(RA)_P = 360^\circ - (ED)_P \approx 297.65623^\circ$  as Sun's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . We find that

$$\begin{aligned} (AD)_P &= \arcsin(\tan \delta_P \times \tan \Phi) \approx \arcsin[\tan(-21.00456^\circ) \times \tan(+33.75^\circ)] \\ &\approx -14.86550^\circ \end{aligned}$$

is Sun's ascensional difference.

Secondly, let's deal with PC1 (the Ascendant). In the tropical SR chart (FIGURE B3), the Ascendant is at Taurus  $14^\circ 40' 30.5''$  with an ecliptic latitude of  $0^\circ$  exactly. Therefore, we have

$$\lambda_{Asc} = 14^\circ 40' 30.5'' \approx 44.67514^\circ, \quad \beta_{Asc} = 0^\circ.$$

We find that the Ascendant's declination is

$$\begin{aligned}\delta_{Asc} &= \arcsin(\sin \varepsilon \times \cos \beta_{Asc} \times \sin \lambda_{Asc} + \cos \varepsilon \times \sin \beta_{Asc}) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 44.67514^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx +16.23828^\circ.\end{aligned}$$

The equinoctial distance here is

$$\begin{aligned}(ED)_{Asc} &= \arccos\left(\frac{\cos \beta_{Asc} \times \cos \lambda_{Asc}}{\cos \delta_{Asc}}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 44.67514^\circ}{\cos(+16.23828^\circ)}\right] \\ &\approx 42.21307^\circ.\end{aligned}$$

Because  $\lambda_{Asc} < 180^\circ$ , we get  $(RA)_{Asc} = (ED)_{Asc} \approx 42.21307^\circ$  as the Ascendant's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . We find that

$$\begin{aligned}(AD)_{Asc} &= \arcsin(\tan \delta_{Asc} \times \tan \Phi) \approx \arcsin[\tan(+16.23828^\circ) \times \tan(+33.75^\circ)] \\ &\approx 11.22183^\circ\end{aligned}$$

is the Ascendant's ascensional difference.

Thirdly, let's deal with the ratio  $R_p$ . In the tropical SR chart (FIGURE B3), the Midheaven is at Capricorn  $28^\circ 51' 10''$  with an ecliptic latitude of  $0^\circ$  exactly. Therefore, we have

$$\lambda_{MC} = 298^\circ 51' 10'' \approx 298.85278^\circ, \quad \beta_{MC} = 0^\circ.$$

We find that the Midheaven's declination is

$$\begin{aligned}\delta_{MC} &= \arcsin(\sin \varepsilon \times \cos \beta_{MC} \times \sin \lambda_{MC} + \cos \varepsilon \times \sin \beta_{MC}) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 298.85278^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx -20.38640^\circ.\end{aligned}$$

The equinoctial distance here is

$$\begin{aligned}(ED)_{MC} &= \arccos\left(\frac{\cos \beta_{MC} \times \cos \lambda_{MC}}{\cos \delta_{MC}}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 298.85278^\circ}{\cos(-20.38640^\circ)}\right] \\ &\approx 59.01553^\circ.\end{aligned}$$

Because  $\lambda_{MC} > 180^\circ$ , we get  $(RA)_{MC} = 360^\circ - (ED)_{MC} \approx 300.98447^\circ$  as the Midheaven's right ascension. We find that

$$R_p = \left| \frac{(RA)_P - (RA)_{MC}}{90^\circ + (AD)_P} \right| \approx \left| \frac{297.65623^\circ - 300.98447^\circ}{90^\circ + (-14.86550^\circ)} \right| \approx 0.04430.$$

Note that  $R_p$  must not exceed the value of 1.

Now we are ready to deal with the arc of direction for the converse Sun-PC1 conjunction. If we take the Sun-PC1 conjunction to be traditionally converse, then

$$\begin{aligned} \text{arc length} &= (RA)_{ASC} - (RA)_P + R_P \times [(AD)_{ASC} - (AD)_P] \\ &\approx 42.21307^\circ - 297.65623^\circ + 0.04430 \times [11.22183^\circ - (-14.86550^\circ)] \\ &\approx -254.28749^\circ \equiv -254.28749^\circ + 360^\circ = 105.71251^\circ . \end{aligned}$$

According to the SR time-key, this arc indicates

$$105.71251 \text{ deg} \times \frac{1.01460101 \text{ days of age}}{1 \text{ deg}} \approx 107.25602 \text{ days of age} ,$$

and so the traditionally converse Sun-PC1 conjunction predicts an event to occur about 107 days after Tuesday, 16 January 1968 (the SR date), which is on Thursday, 02 May 1968 (Day 123 of 1968).

If we take the Sun-PC1 conjunction to be neo-converse, then

$$\begin{aligned} \text{arc length} &= (RA)_{ASC} - (RA)_P - [(AD)_{ASC} - (AD)_P] \\ &\approx 42.21307^\circ - 297.65623^\circ - [11.22183^\circ - (-14.86550^\circ)] \\ &= -281.53049^\circ \equiv -281.53049^\circ + 360^\circ = 78.46951^\circ . \end{aligned}$$

According to the SR time-key, this arc indicates

$$78.46951 \text{ deg} \times \frac{1.01460101 \text{ days of age}}{1 \text{ deg}} \approx 79.61524 \text{ days of age} ,$$

and so the neo-converse Sun-PC1 conjunction predicts an event to occur about 80 days after Tuesday, 16 January 1968 (the SR date), which is on Friday, 05 April 1968 (Day 96 of 1968).

## B4 The LR Mars-PC1 square

FIGURE B4 presents King's last LR chart in terms of tropical whole-sign houses.

Regarding this chart, the Mars-PC1 square is a direct primary direction in which Mars's sinister-square copy is the promissor and PC1 (the Ascendant) is the significator. For this situation, we have

$$\text{arc length} = (OA)_P - (OA)_{ASC} ,$$

where the subscript  $P$  refers to the promissor.

Firstly, let's deal with Mars's sinister-square copy. In the tropical LR chart (FIGURE B4), Mars is at Aries  $29^\circ 37' 21''$  with an ecliptic latitude of  $-00^\circ 05' 18''$ . Its sinister-square copy is at Cancer  $29^\circ 37' 21''$  with a Bianchini ecliptic latitude of  $(-00^\circ 05' 18'') \times \cos 90^\circ = 0^\circ$ . Therefore, we have

$$\lambda_P = 119^\circ 37' 21'' = 119.62250^\circ , \quad \beta_P = 0^\circ .$$

We find that the copy's declination is

$$\begin{aligned} \delta_p &= \arcsin(\sin \varepsilon \times \cos \beta_p \times \sin \lambda_p + \cos \varepsilon \times \sin \beta_p) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 119.62250^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx +20.22697^\circ. \end{aligned}$$

The equinoctial distance here is

$$\begin{aligned} (ED)_p &= \arccos\left(\frac{\cos \beta_p \times \cos \lambda_p}{\cos \delta_p}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 119.62250^\circ}{\cos(+20.22697^\circ)}\right] \\ &\approx 121.78740^\circ. \end{aligned}$$

Because  $\lambda_p < 180^\circ$ , we get  $(RA)_p = (ED)_p \approx 121.78740^\circ$  as the copy's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . For the copy's ascensional difference, we get

$$\begin{aligned} (AD)_p &= \arcsin(\tan \delta_p \times \tan \Phi) \approx \arcsin[\tan(+20.22697^\circ) \times \tan(+33.75^\circ)] \\ &\approx 14.25270^\circ, \end{aligned}$$

and so

$$(OA)_p = (RA)_p - (AD)_p \approx 121.78740^\circ - 14.25270^\circ = 107.53470^\circ$$

is the copy's oblique ascension.

Secondly, let's deal with PC1 (the Ascendant). In the tropical LR chart (FIGURE B4), the Ascendant is at Aries 03° 36' 50'' with an ecliptic latitude of 0° exactly. Therefore, we have

$$\lambda_{Asc} = 03^\circ 36' 50'' \approx 3.61389^\circ, \quad \beta_{Asc} = 0^\circ.$$

We find that the Ascendant's declination is

$$\begin{aligned}\delta_{Asc} &= \arcsin(\sin \varepsilon \times \cos \beta_{Asc} \times \sin \lambda_{Asc} + \cos \varepsilon \times \sin \beta_{Asc}) \\ &\approx \arcsin(\sin 23.43583^\circ \times \cos 0^\circ \times \sin 3.61389^\circ + \cos 23.43583^\circ \times \sin 0^\circ) \\ &\approx +1.43652^\circ.\end{aligned}$$

The equinoctial distance here is

$$\begin{aligned}(ED)_{Asc} &= \arccos\left(\frac{\cos \beta_{Asc} \times \cos \lambda_{Asc}}{\cos \delta_{Asc}}\right) \approx \arccos\left[\frac{\cos 0^\circ \times \cos 3.61389^\circ}{\cos(+1.43652^\circ)}\right] \\ &\approx 3.31646^\circ.\end{aligned}$$

Because  $\lambda_{Asc} < 180^\circ$ , we get  $(RA)_{Asc} = (ED)_{Asc} \approx 3.31646^\circ$  as the Ascendant's right ascension. King's geographic latitude of birth is  $\Phi = 33^\circ 45' N = +33.75^\circ$ . For the Ascendant's ascensional difference, we get

$$\begin{aligned}(AD)_{Asc} &= \arcsin(\tan \delta_{Asc} \times \tan \Phi) \approx \arcsin[\tan(+1.43652^\circ) \times \tan(+33.75^\circ)] \\ &\approx 0.96010^\circ,\end{aligned}$$

and so

$$(OA)_{Asc} = (RA)_{Asc} - (AD)_{Asc} \approx 3.31646^\circ - 0.96010^\circ = 2.35636^\circ$$

is the Ascendant's oblique ascension.

Now we are ready to deal with the arc of direction for the direct Mars-PC1 square. We find that

$$\text{arc length} = (OA)_P - (OA)_{Asc} \approx 107.53470^\circ - 2.35636^\circ = 105.17834^\circ.$$

According to the LR time-key, this arc indicates

$$105.17834 \text{ deg} \times \frac{0.0758935056 \text{ days of age}}{1 \text{ deg}} \approx 7.98235 \text{ days of age},$$

and so the direct Mars-PC1 square predicts an event to occur about 8 days after Wednesday, 27 March 1968 (the LR date), which is on Thursday, 04 April 1968 (Day 95 of 1968).
